This resolution supersedes CR-10-2020.

The general boundaries of the West Hyattsville-Queens Chapel Sector are the District of Columbia on the southwest, the western boundary of Planning Area 68 on the west, the southern boundary of the 2016 Prince George's Plaza Transit District Development Plan and MD 410 (East West Highway) on the north, and MD 500 (Queens Chapel Road), the rear property lines of properties along the south or east sides of 38th Avenue, the rear property lines of properties along the north side of Allison Street, and Arundel Road on the east and southeast.

The purpose of this notice is to remind citizens and property owners that a planning process has been underway in this area for over a year and, to facilitate implementation of that sector plan upon its approval, the District Council has directed the Planning Board to prepare an SMA. This SMA will be prepared by the Planning Department and released for public review and comment in the late spring/early summer of 2022.
