The work comprises primarily of concrete remediation for trip hazards mitigation, together with asphalt base repairs / cut & patch work in the adjacent areas; concrete sidewalks; curb & gutters; handicap ramps; driveway aprons and under-drains.

4. Minimum Qualifications:

The Contractor must have a minimum of five (5) year experience of performing work of similar nature.
