# **United Way of the National Capital Area Supports Local Students with** 2024 'Stuff the Bus' Event

WASHINGTON, D.C. (August 9, 2024)— United Way of the National Capital Area (United Way NCA) held their annual Stuff the Bus event earlier this week—providing school supplies to 1,200 middle and high school students in the region.

The Stuff the Bus initiative created by United Way of the National Capital Area (United Way NCA) helps to bridge the gap to equitable access to education for students in and around the National Capital region. Through the 2024 Stuff the Bus campaign, 1,200 students at seven Title 1 community schools in Washington, D.C., Maryland, and Virginia received backpacks filled with grade-appropriate school supplies.

ALICE is an acronym for Asset Limited, Income Constrained, Employed and it represents the more than 500,000 low- and moderate-income households in the National Capital Area earning above the Federal Poverty Level but below what's needed to survive in the current economy. United Way NCA's ALICE Lives Here initiative aims to reduce disparities in the areas of health, education and economic opportunity and improve outcomes for individuals and families in the National Capital Area.

According to the most recent ALICE in the Crosscurrents report (May 2024), 31% of Washington, D.C., families with children were below the ALICE threshold. In Maryland and Virginia, the number of households with children that were below the ALICE threshold were 34% and 35%, respectively. By providing school essentials for students living in ALICE households, United Way NCA is reducing back-to-school costs for families

# **Governor Announces \$9.2 Million Renewable Energy Workforce Development Program for Maryland Higher Education Institutions**

ANNAPOLIS, MD (August 9, 2024)—Governor Wes Moore today announced the launch of the Higher Education Clean Energy Grant Pilot Program, a \$9.2 million competitive pilot opportunity to support clean energy transitions within Maryland's colleges and universities. The program will promote both workforce development and Maryland's climate goals by funding solar installations, comprehensive campus clean energy planning, and specialized renewable energy sector academic programming.

"We need to prepare the next generation of Marylanders to lead industries of the future. Today, our administration takes an important step toward doing exactly that by investing in programs that will arm students with the skills they need to compete for jobs in clean energy," said Gov. Moore. "Together, we are demonstrating how climate action builds new pathways to work, wages, and wealth."

The pilot program is open to all of the state's accredited twoand four-year colleges and universities. Participation must support workforce development programs that design courses and curricula focused on skills for careers in the renewable energy industry, in addition to internships that encourage handson student involvement in campus sustainability and workforce development projects.

The pilot provides funding for several key clean energy initiatives, including solar panel installation on Maryland's campuses to boost onsite renewable energy production. Participating intuitions have the option to use or sell the renewable energy they generate. Funding will also support creation of campus clean energy master plans, which outline strategic paths for campuses to reduce energy consumption, integrate renewable energy, and reach sustainability goals.

"Maryland's higher education institutions have a key role to play in reducing the state's carbon footprint, while fostering the next generation of clean energy professionals," said Maryland Energy Administration Director Paul G. Pinsky. "This pilot program empowers campuses to lead by example, creating cutting-edge energy solutions and providing students with essential opportunities in the booming green economy."

Colleges and universities have until October 30 to review program guidelines and submit applications for consideration.

# IRS, States, Tax Industry **Announce New Joint Effort** to Combat Growing Scams and Schemes

Ongoing Coordination to Follow in Footsteps of Security Summit's *Identity Theft Efforts to Help Taxpayers and Protect Revenue*

WASHINGTON, D.C. (August 16, Internal Revenue Service, state tax agencies and the spectrum of the nation's tax industry today announced a new joint effort to combat the growth of scams and schemes threatening taxpayers and tax systems.

The new combined effort follows a variety of increased scams and schemes that intensified during the past filing season that aimed to exploit vulnerable taxpayers while enriching fraudsters and promoters.


Convened at the request of IRS Commissioner Danny Werfel, the coalition of federal and state tax agencies along with software and financial companies as well as key national tax professional associations agreed to a three-pronged approach. They will work to expand outreach and education about emerging scams, develop new approaches to identify potentially fraudulent returns at the point of filing and create infrastructure improvements to protect taxpayers as well as federal, state and industry tax systems.

The new task force will be called the Coalition Against Scam and Scheme Threats (CASST).

"Across the spectrum of the tax 2024)—A coalition representing the system, we've seen a rising tide of scams and schemes that try to exploit taxpayers and find gaps in government and industry defenses," Werfel said. "This new collaborative approach will allow the private and public sectors to throw our combined weight against this threat. We will do more to work closely together, share information faster, respond quickly to threats and quickly alert the public to new and emerging threats. Our goal is to have a mass effect on this expanding problem that's spread on social media and through bad actors."

The new CASST project has wide support across the nation's tax community. In addition to the IRS, other participants include state tax agencies represented by the Federation of Tax Administrators as well as the leading software and financial industries working in the tax space and key na-

# 8 New Schools Planned for Prince George's

The County Council has approved construction of eight schools which will replace 14 outdated schools and add about 8,000 seats.

The new schools include Fairwood Area Elementary in Bowie

and Margaret Brent Elementary in New Carrollton, both of which will open by 2026.

Other schools include Springhill Lake Elementary, in Greenbelt; Templeton Elementary, Riverdale Park; James Duckworth Elementary, Beltsville; Hyattsville Elementary; Robert Frost Area PK-8; New Carrollton; and—closest to us—Brandywine Area PK. It's expected construction will begin next month.

I have two questions: Why are almost all the schools in the northern part of the County? And which are the "14 outdated schools?"

# County Celebrates New Behavioral Health Crisis Center

An Update from County Executive Angela Alsobrooks

Last week, we hosted the ribbon cutting ceremony for the new Dyer Care Crisis Stabilization Center, a very important facility that will help our County lead the way on mental healthcare. This new emergency care center meets stringent national guidelines for crisis care and will help us provide residents with the services they need during a behavioral health crisis.

Providing behavioral health crisis care is part of our overarching strategy to improve healthcare access for Prince Georgians. It was clear to us that Prince Georgians needed greater access to behavioral and mental health resources, which is why we have worked to improve healthcare for all of our residents by opening new hospitals, new medical offices, new behavioral health facilities, and facilities for women's health across the County since the beginning of my administration.

For too long, our mental healthcare infrastructure has not met the needs of residents. Countless communities across our country do not have adequate facilities for people in crisis and too many people who are experiencing a mental health crisis are met with delays, denial of services, and even imprisonment. This is why we are working so hard to improve access to quality behavioral healthcare and why we are so proud to have taken yet another important step forward in providing mental healthcare and resources for Prince Georgians.

The Dyer Care Center is a state-of-the-art crisis stabilization facility that will provide access to mental health services for all, accepting walk-ins, police drop-offs, and ambulance drop-offs. The Center works like an Emergency Room for people experiencing a mental health crisis. Simply put, the Dyer Center is a place where people who feel lost can find compassion, guidance, and a path to follow. It is a place where our residents will receive care that is befitting of their dignity, care that meets their basic needs and care that helps ensure that we, as a community, are providing opportunities for a brighter future.

We are so grateful to be adding this important crisis stabilization center to our community. From now on, the Dyer Care Center will be here, providing a safe place for Prince Georgians and Marylanders during their greatest time of need.



# The Power of the Gumbo Spirit was On Display at Paris Olympics

The power of the Gumbo spirit was on full display in Team USA at the 2024 Olympic Games in Paris.

The most diverse women's gymnastics team in U.S. history was the most decorated, with 10 medals total, 3 of them gold, including the coveted individual all-around.

Team USA members of every racial and ethnic background found success in Paris, bringing home the gold in track and field, swimming, and other events. But the diversity of the women's gymnastics team has captured the world's attention, given the historic exclusion of women of color from the sport.

When Dominique Dawes competed in the Olympic trials for the 1992 Barcelona Games, she was the first Black gymnast to ever qualify. She was part of the celebrated "Magnificent Seven" in the 1996 Atlanta games who won the first-ever

gold medal for the United States in the women's team competition.

A decade after Dawes Olympics debut, Gabby Douglas became the first Black woman of any nationality to win the all-around gold medal in gymnastics.

It would be absurd to argue that Black women were absent from Olympic gymnastics for nearly a century because of a lack of talent. It is an equally absurd argument to make about executive leadership in the nation's top corporations, admissions to elite colleges and universities, or the Oval Office.

The anti-racial justice extremists who want to ban DEI policies would doom Team USA to mediocrity just to assure their own place on the roster

Diverse organizations—from Fortune 500 companies to Olympic gymnastics teams— perform better than exclusive organizations. People from different backgrounds bring a wealth of different experiences, knowledge, and skills. One study found that diverse and inclusive teams made better decisions than individuals 87% of the time.

Diverse companies see higher revenue, with 75% of companies with strong DEI policies in their management teams will surpass their financial goals.

The gymnastics world did not sit passively by and wait for a fully-trained Simone Biles to find her own way, unbidden, to the National Championships in 2012. Were it not for a sharp-eyed coach who noticed the tiny 6-year-old on a day-care field trip to a gym, Biles may never have been steered toward the sport. Today she is almost universally recognized as the greatest gymnast of all time.

The leaders of the so-called "anti-woke" movement would rather dominate second-rate institutions than collaborate to build world-class organizations.

We can give thanks, at least, they're not entrusted to assemble our sports teams.

# The IRA is Still Our Biggest Step Toward a Brighter Future for Our Children

I often think about a factory hallway in Dalton, Georgia that is filled with pictures drawn by children. It is a reminder of what can be, what will be, thanks to the historic Inflation Reduction Act (IRA), which celebrates its second anniversary this month.

The drawings capture how these children see their parents who work at this solar manufacturing plant. There are pictures of beautiful sunny days, of the earth with pristine water. Of their parents saving the world. These children see their parents as superheroes. As I remember these pictures, I wonder: how can anyone not be inspired by these children to fight every day for a better, livable future? For more clean energy jobs, in big cities and rural communities across the country, that will power our economy – and our homes – for generations to come?

Around this anniversary, the news has been filled with reflection on what the IRA has achieved and what still needs to be done. It is – as it should be – a major focal point at the Democratic National Convention happening now in Chicago.

You do not have to look hard to find examples of its success. More than 334,000 new clean energy jobs have been created across the country. More than 3 million U.S. households have collectively saved over \$8 billion on upgrades that will save them money and make their homes more energy efficient. In Illinois alone, for example, nearly 140,000 residents claimed more than \$260 million in tax credits on their 2023 tax returns for installing solar or

making other energy efficiency improvements on their homes.

One fact should loom larger than most: the IRA is still this nation's biggest single step ever toward securing a healthy and livable planet for all. No other single piece of legislation has done more to address our climate goals and support the clean energy revolution already underway. Through the Climate Pollution Reduction Grants program, the IRA is projected to reduce greenhouse gas pollution by as much as 971 million metric tons of carbon dioxide equivalent by 2050. That's equivalent to the emissions from about 5 million homes' energy use every year for more than 25 years.

Need a reminder of the urgency and necessity of this investment in combating the climate crisis? Just turn on the news. Or step outside. We are experiencing the hottest summer on record ... in the hottest year on record. Supercharged storms and wildfires from all that heat are impacting more and more Americans. Hurricane Ernesto is just the latest storm to batter homes and businesses and leave hundreds of thousands of Americans without power. With so many people hurting and at risk, the IRA remains one of our most powerful tools to mitigate climate change's harm. We must continue to learn from our experience implementing it, fill gaps where we see them, and double down on our efforts to protect people, places and the planet we call home. And we must remember that throwing everything we have at combating the climate crisis is also the way America wins in the next economy.

In the decades since the North American Free Trade Agreement (NAFTA), the shipping of U.S. jobs overseas has helped destroy towns and cities across America. Now, the IRA is fueling a manufacturing rebirth that is creating good-paying jobs while bringing our energy economy into the 21st century.

Plans to build a new solar cell factory near Minneapolis, Minnesota are currently underway. This factory will create more clean energy jobs in the Midwest while addressing the need for more American-made solar cells. The solar company Heliene, which co-owns the project, publicly credits the IRA's tax credits for inspiring its decision to invest in U.S. solar manufacturing.

Just an hour drive away from Minneapolis is the town of Becker. It is the home to one of the largest coal-burning power plants in the country. Yet Becker will soon be known for something else: being a national leader in the transition to clean, renewable energy. Xcel Energy is fully retiring the Sherco coalburning power plant by 2030. Literally within eyesight of the old plant, they are building what will become the fifth largest solar project in the United States. Taking advantage of new and extended tax credits and grant programs, the Sherco solar and energy storage facility will bring 1.8 million solar panels online in 2026. It will employ hundreds of workers – many of them moving over from the coal plant – and power more than 150,000 Midwest homes each year.

The IRA was always designed to set us up for long-term economic success. Part of how it achieves this is by putting money back into Americans' pockets and ensuring that no community is left out of the transition to cleaner, safer, and more affordable clean energy. Tax credits and rebates are lowering the cost of home improvements and electric vehicles that themselves will save consumers money. The Solar For All program is awarding \$7 billion to projects across the country that will help over 900,000 low-income households benefit from solar energy.

We owe it to ourselves and to our kids to build on this momentum. On this IRA anniversary, I think of those children in Dalton and children in communities big and small across the country. I am excited for all the pictures to come if we get this right.

# **Social Security Matters**

**Ask Rusty:** 

# **Does Some of My Social Security Payment Include Repayment of My Contributions?**

**Dear Rusty:** I have a question about my Social Security benefits. Would I be correct to assume that part of the monthly Social Security income I get is a repayment of what I contributed to the fund while I was working? If so, how much of my monthly benefit payment is my own money coming back to me? Signed: Curious Beneficiary

Dear Curious: I'm afraid that is not how Social Security works. The money you contribute to Social Security during your working years does not go into a special account to be repaid to you. Rather, the Social Security taxes you pay while working are used to pay benefits to all those currently receiving Social Security benefits. The system is, in effect, a "pay as you go" program where all those currently contributing help pay benefits for all those now receiving. What your contributions do, however, is earn you "quarter credits" and, when you have enough credits, you become eligible for Social Security retirement benefits for life. Generally, someone must have about 40 quarters (about 10 years) contributing to Social Security to be eligible for SS retirement benefits.

How much you receive monthly is determined not by how much you contributed but, rather, by how much your work earnings were over your lifetime. You will get a percentage of your average preretirement work income as your monthly Social Security payment, but that is also affected by your age when you claim benefits. It is your average lifetime earnings (adjusted for inflation) which determines your "Primary Insurance Amount" (or "PIA"). Your PIA is what you get at your Social Security full retirement age (FRA), but your age when you claim benefits determines if you get more or less than your PIA. Claiming SS before your FRA means a smaller monthly benefit, while waiting longer than your FRA means a benefit higher than your PIA. (SS benefits reach maximum at age 70). FYI, each person's FRA is different based on the year they were born, but full retirement age today is between age 66 and 67. When you claim benefits relative to your FRA determines how much of your PIA you will receive each month.

So, your contributions to Social Security aren't used to determine your monthly benefit amount, but your average lifetime work earnings and age when you claim are. Nevertheless, you may be interested to know that most people get back everything they have personally contributed to Social Security within about 3 to 5 years of collecting their benefits. In that sense, Social Security is an exceptionally good deal, since most Americans now collect benefits for about two decades. And therein lies much of Social Security's financial dilemma - people are now collecting benefits for many more years than the current program is designed to support. And that is what Congress needs to fix as soon as possible. The Social Security trust funds (which now provide supplemental money to pay benefits) are projected to be depleted around 2033, which will mean a cut in everyone's monthly Social Security payment, unless Congress acts soon to reform the program and restore it to fiscal solvency.

tional tax professional organizations. The Council for Electronic Revenue Communication Advancement, the National Association of Computerized Tax Processors and the American Coalition for Taxpayer Rights are among those that have signed on to support the initiative. In all, more than 60 different groups from the private sector have signed on to the initiative, either individually or as part of a group.

"The FTA membership is dedicated to protecting taxpayers from fraudulent attacks on the country's tax ecosystem," said Federation of Tax Administrators Executive Director Sharonne Bonardi. "We are committed to continuing our collaborative efforts by working with the IRS, industry and other stakeholders to implement strategies that allow for proactive detection, prevention and mitigation of scams and schemes deployed by bad actors intending to defraud tax agencies."

The new coalition is an outgrowth of the Security Summit effort, and while the new collaborative effort will not replace the Summit, the scams coalition will be closely modeled on the

Summit. The Security Summit was launched in 2015 by the same groups to stem the growth in tax-related identity theft. The combined effort improved information sharing between the groups, identified common approaches to combat tax-related identity theft, improved internal tax system defenses and conducted extensive public awareness campaigns for taxpayers and tax professionals. While tax-related identity theft remains a concern, the improved protections have protected millions of taxpayers and prevented billions of dollars of fraudulent payments.

For this new project targeting scams, the CASST task force has agreed to high-level principles. The purpose of the group will be to better protect taxpayers from falling prey to unscrupulous actors by leveraging multilateral relationships across the tax ecosystem to minimize the filing of fraudulent tax returns.

"CERCA is pleased to work with the IRS and the states to combat the proliferation of 'scams and schemes' that are victimizing millions of Americans," said Shannon Bond, chair of the Council for Electronic Revenue Communication Advancement. CERCA represents companies in

the tax software and preparation industries as well as financial service groups and others in the tax community. "Continuing our long partnership with the IRS, CERCA stands shoulder to shoulder with both the federal government and the states to reduce first-party fraud, which threatens the viability of tax systems and imperils vulnerable taxpayers.

During the past tax season, there has been increased activity involving a variety of scams and schemes harming taxpayers, including the Fuel Tax Credit, household employment taxes and the Sick and Family Leave Credit. The IRS has seen hundreds of thousands of dubious claims come in where it appears taxpayers are claiming credits for which they are not eligible, leading to refunds being delayed and the need for taxpayers to show they have legitimate documentation to support

Numerous other scams and schemes continue to be seen circulating on social media and are highlighted through efforts including the annual IRS Dirty Dozen list and alerts from the Security Summit partners. The new approach will increase collaborative efforts to raise awareness and education about schemes, not just during tax season but throughout the year.

With the new scam and scheme initiatives, the IRS, states and the private sector will work to put in place new protections by filing season 2025. The combined effort is particularly important because the group has seen instances where scammers look for weak points in government systems and the private sector to exploit. The combined effort will improve defenses across both the private and public sector with a goal of making it more difficult for scammers to slip improper or false tax returns through the system.

The group will also work to make long-term structural changes to fundamentally improve the ability to identify and stop scams. This includes working to improve EFIN and PTIN validation and new steps to combat "ghost preparers," who prepare tax returns for a fee and do not in any way sign a tax return or disclose their role on the tax return as the preparer. In many cases, these are inflated tax refunds that lead to millions in revenue loss and add risk for taxpayers who file potentially improper claims with only the individual's name associated with the tax return.

# What are some "nature-based solutions" to fight climate change?

Dear EarthTalk:

What are some "nature-based solutions" to fight climate change?

As we come to terms with the growing effects of climate change, many are turning to so-called nature-based solutions, which are holistic approaches that promote biodiversity and ecosystem preservation. Nature-based solutions harness natural processes to address problems rooted in climate change. Countries such as Africa, the Philippines and Brazil are at the forefront of using nature-based solutions.

One example of a nature-based solution is reforestation, the replanting of native trees in areas subject to deforestation. Many initiatives are underway to restore regions of the world negatively affected by logging, burning and land use change. For example, Africa's Great Green Wall project aims to restore 100 million hectares of degraded land across 20 countries. This is already dramatically reducing atmospheric carbon in the region while providing a livelihood for local communities.

Mangroves are a lesser-known climate champion, essential for both carbon storage and coastal protection. The Zoological Society of London (ZSL) is spearheading an extensive mangrove restoration program in the Philippines where over 50 percent of mangrove habitats have been lost. By regrowing the mangroves that line the islands, they are building a defense against rising sea levels.

Urban greening is perhaps one of the most easily accessible nature-based solutions and is most advantageous in areas with little to no nature already present. An example of this is New York City's High Line, a 1.5-mile long track that was previously abandoned before it was

transformed by Friends of the Highline who now use it as a community space to grow native plants, host events and display local art. Urban greening is highly effective, easy, and beneficial to communities.

Agroforestry integrates trees and native brush into farms to mimic natural environments. In Brazil's Atlantic Forest, agroforestry has been instrumental in transforming disrupted land into systems that support biodiversity without costing communities who rely on farms. Such projects promote soil health, improve water retention and support the spread of nutrients. Planting trees around farmland or introducing wildflower seeds at the edge of a property can be instrumental in promoting ecosystem health.

Nature-based solutions may often be presented as large-scale initiatives, but such solutions are still vital and more accessible in a smaller context. Consider joining an ongoing project in your area, or starting one yourself, taking inspiration from other established programs around the world.
