Sky Bridge at Town Center **Hawaiian Celebration Sparks Sweet Memories for Resident**

Through the recent luau party held by the Watermark Retirement community, one resident got the chance to relive happy memories.

UPPER MARLBORO, Md. (Sept. 9, 2024)—The halls of the Sky Bridge at Town Center rang with the beat of drums and the sounds of Hawaiian music during the community's luau on Aug. 28. Traditional dancers performed a historical war dance and a hula for the seniors, while many residents dressed up and enjoyed a specially made meal from the community's chef.

For one resident, Mattie Norwood, the luau was a chance to dance and enjoy a wonderful day with her fellow residents. It also sparked happy memories of her time living in Hawaii in the 1980s.

Norwood, who has lived at the Sky Bridge at Town Center since it opened in December 2022, called Hawaii home for four years after her family moved for her husband's work at the military base on Oahu.

Transportation Security Administration Publishes Proposed Regulation That Provides Necessary Flexibility as Federal Agencies Prepare to Enforce **REAL ID Requirements Beginning May 7, 2025**

WASHINGTON (Sept. 12, 2024)—The Transportation Security Administration (TSA) published a Notice of Proposed Rulemaking that would provide federal agencies with necessary

flexibility to begin enforcement to begin enforcing REAL ID reof the REAL ID regulations on the May 7, 2025, deadline in a manner that takes into account security, operational risk and public impact.


This proposed rule seeks to ensure that federal agencies, including TSA, are well positioned

quirements on May 7, 2025. The proposed rule does not extend the REAL ID deadline. Instead, it would allow TSA to consider a phased enforcement approach to REAL ID implementation. Travelers without a REAL ID compliant ID or another form of

acceptable ID after the May 7, 2025 deadline could face delays at airport security checkpoints.

"TSA is engaging with the public, licensing jurisdictions and states to facilitate a smooth

Art Rehkemper, 30 years in **Secret Service**

Arthur Rehkemper, who spent his life in the law enforcement community, died August 5 at his home in Catonsville. He was 80.

Art was born in Pana, Ill., and spent his childhood as an Air Force "brat." The family settled in District Heights in the '50s. He attended Mount Calvary, Gonzaga and Archbishop Carroll and graduated from the University of Maryland. He was a lifelong Terp fan and loved the Redskins and Nationals.

transition to REAL ID enforcement beginning May 7, 2025," said TSA Administrator David Pekoske. "REAL ID provides an important security enhancement, and this rule allows us to plan for a range of scenarios to help minimize the potential impact to travelers, industry stakeholders and states during implementation."

The REAL ID Act, which was enacted following the 9/11 Commission's recommendation, established minimum security standards for state-issued drivers' licenses and identification cards for the purpose of boarding federally regulated commercial aircraft, accessing certain federal facilities, and entering nuclear power plants. Identity verification is foundational to security. Enforcement of the REAL ID Act and regulations enhances TSA's ability to accurately verify a traveler's identity document.



Residents will also enjoy access to the amenities delivered in phases I and II, including the 5,700 square foot community clubhouse, fitness center, management suite, resource center, locker rooms, kitchenette, outdoor patio with a grill, tot-lot, theater room, wellness room, and more.

Social Security Matters

Ask Rusty:

About Widow's Benefits vs. **Benefits From my Ex-spouse**

Dear Rusty: In November I will be 60 and eligible for widow's benefits. My late husband's Social Security was approximately \$2,300 when he passed around 7 years ago. FYI, my ex-husband is still working and will probably receive the highest SS when he retires in about 5 years (we were married for more than 10 years). Either of these is more than my own Social Security will be, so how does this work? Will this turn into my Social Security? Can I start on one and switch to the other later? Signed: Wondering Widow t

Dear Wondering Widow: Provided you have not remarried before age 60, you have a choice which benefit to receive—either your deceased husband's benefit as his surviving spouse, or your ex-spouse benefit from your ex-husband while he is still living. Taking your survivor benefit from your deceased husband will likely be best because it is based on 100% of his SS amount when he died, whereas your exspouse benefit from your living ex-husband is based on 50% of his FRA entitlement. To get an ex-spouse benefit from your ex-husband (which you can't get until you are 62), your own SS retirement benefit would need to be less than 50% of your ex's FRA entitlement.

As you know, you will be eligible for survivor (widow's) benefits from your deceased husband when you are 60 but be aware that by taking your survivor benefit at 60, it will be reduced for early claiming. Rather than 100% of your husband's SS benefit, at age 60 you will get about 71.5%. Your surviving spouse benefit reaches maximum at your full retirement age (FRA) of 67 and will grow to that point but will be reduced if taken prior to that.

Also, if you are working, Social Security's "earnings test" will apply until you reach your full retirement age, so your plans for working may influence your decision on when to claim your widow's benefit. If you exceed the earnings limit (\$22,320 for 2024; it changes annually), Social Security will take away \$1 in benefits for every \$2 you are over the limit. They "take away" by withholding future benefits until the penalty is satisfied, which means you would go some number of months without benefits. And, if you substantially exceed the earnings limit you may even be temporarily ineligible for any SS benefits (until you earn less or reach your FRA - the earnings test goes away at your FRA).

If you claim your surviving spouse benefits from your deceased husband first, and your ex-husband later dies, you do have the option to switch to the higher survivor benefit from your ex-husband. In effect, if both husbands are deceased, you have a choice which benefit to take (and, obviously, you'd chose the higher of the two).

None of this, however, happens automatically. To claim your surviving spouse benefit you will need to contact Social Security directly at 1.800.772.1213 (or call your local SS office) to make an appointment to apply for widow's benefits.

Dear EarthTalk:

How can homeowners make their homes greener and more efficient to cash in on rebates and incentives available under Biden's Inflation Reduction Act?

-Bill O., Dewey, OK

Joe Biden's 2022 Inflation Reduction Act created \$8.8 billion in tax credits and rebates to help lower- and middle-income homeowners contribute to the country's emission reduction goals. As with prior housing policy, the act defines lower- and middle-income Americans as those making 150 percent or less of their Area Median Income, or the midpoint of their local area's income distribution. The bulk of these incentives come from federal tax credits which, like the act's state-based rebates, are available through September 2031, and can be applied retroactively to purchases and installations after August 2022.

The Residential Clean Energy Tax Credit covers up to 30 percent of installation costs for alternative energy sources including solar panels, small wind turbines, geothermal heat pumps and battery storage systems. The \$3,200 Energy Efficient Home Improvement Credit, on the other hand, covers upgrades to

existing energy sources. The credit can be applied with a cap of \$1,200 to new windows and skylights (up to \$600), new doors (up to \$500), and improvements to insulation (up to 30 percent).

Out of the 23 total states that have applied for rebate program funding, eight have recently been approved: Arizona, California, Hawaii, Indiana, Maine, New Mexico, Rhode Island and Washington. Two more, New York and Wisconsin, have already begun distribution. The Department of Energy expects that several states will join them later in 2024 beginning with the Home Efficiency Rebate Program (HOMES), which will offer rebates of up to \$8,000 and \$4,000 respectively for low- and middle-income households that can cut energy usage by 35 percent or more.

The Home Electrification and Appliance Rebate (HEAR) boasts a cap of \$14,000 in rebates per household and is expected to follow implementation of HOMES. Under HEAR, low and middle income homeowners can expect 50-100 percent point of sale coverage on several appliances including up to \$8,000 for electric heat pumps; \$1,600 for insulation and air sealing; \$2,500 for electric wiring; and \$840 for electric stoves, ovens and heat pump clothes dryers.

Energy upgrades have the potential to save homeowners money far beyond installation. For example, more efficient homes can mean reduced energy bills. Furthermore, green homes can qualify for benefits such as a \$5,000 tax credit if they meet the Department of Energy Zero Energy Ready Home (ZERH) standards. A qualified home energy auditor can help homeowners looking to cash in on the myriads of incentives determine which upgrades fit best with their homes and budgets.
