## **Gov. Moore Puts \$1.8 Million Toward Making Maryland** the "Cyber Capital" of the Nation

COLUMBIA, Md. (Nov. 22, 2024)—Gov. Wes Moore this week announced a \$1.8 million award to all 16 community colleges in the state to boost cybersecurity training and career opportunities.

The Maryland Association of Community Colleges and

Accelerating Cyber Careers grant by the Maryland Department of Labor.

BCR Cyber, an interactive computer platform that simulates real-world cyber-attacks, will provide experiential learning for students.

In his remarks at Thursday morning's announcement, he said he hopes that Maryland will become the hotbed for aspiring cybersecurity professionals.

"Maryland's pathway to national leadership in cybersecurity runs through our community colleges," Moore said. "Today marks the latest chapter in our work to make Maryland the cyber capital of the United States and connect all Marylanders with the training they need to compete for jobs of tomorrow."

Moore's administration secured the award for the MACC and for BCR Cyber. The funding comes from the

current federal, state, and local investment in cyber ranges, this partnership offers a statewide solution that will dramatically increase Maryland's capacity to generate cyber workforce talent in a statewide unified program," said Michael Spector, president of BCR Cyber."

Brad Phillips, executive director of the Maryland Association of Community Colleges, agreed.

"This investment solidifies Maryland community colleges as a national leader on cyber and workforce development," said Phillips. "We're honored to be chosen for this award and look forward to working with our partners to fill critical skills gaps in the cybersecurity industry."

Rental income assistance from the US Department of Housing (HUD) helps ensure residents pay no more than 30% of their income in rent. Fellowship Square relies on volunteers, community partners, financial donors and others to provide quality programs and activities for Largo Landing residents.

"Thanksgiving is a time to express gratitude, and there's no better way to do that than by giving back to our senior community, who have laid the

foundation for all of us," said Councilmember Blegay. "Our seniors are pillars of wisdom, strength, and resilience, and this distribution of turkey and other Thanksgiving food is a small token of appreciation for their countless contributions."

The donated packages included a turkey, produce, and all the fixings for residents to enjoy a festive Thanksgiving

meal. The giveaways are a partnership between Council Member Blegay's office, the Community Impact Office, Abundant Life Church, and local businesses.

"We're thankful to have a wonderful partner in Councilmember Blegay," said Christy Zeitz, CEO of Fellowship Square. "Her support and dedication to our mission has a

## **Prince George's County Health Department to Transition Medication Assisted Treatment Services** by March 2025

Health Department shifts focus to community partnership for enhanced access to Medication Assisted Treatment services

LARGO, Md. (Dec. 2, 2024)-The Prince George's County Health Department announces an important shift in its approach to providing Medication Assisted Treatment (MAT) services. Effective March 31, 2025, the Health Department will transition from directly offering MAT services to focusing on facilitating partnerships that enhance access to these vital services within the community.

This strategic decision aligns with the principles of Public Health 3.0, emphasizing collaboration, sustainability, and community-centered solutions. In partnership with the Local Behavioral Health Authority (LBHA), the Health Department is actively supporting the establishment of a new methadone treatment clinic in central or southern Prince George's County. This initiative aims to ensure individuals seeking MAT services have uninterrupted access to care in a more coordinated and effective manner.

"Our priority has always been to serve our residents with the

highest level of care and support," said Dr. Matthew D. Levy, Prince George's County Health Officer. "This transition reflects our commitment to building a stronger healthcare system that fosters collaboration, sustainability, and equitable access to services."

The Health Department is dedicated to ensuring that current patients receive comprehensive resources and guidance to facilitate a seamless transition to new treatment providers. Prospective and current patients will be connected with care coordination, case management, and peer recovery coaches to help navigate the process.

Patients seeking new or continued treatment will have access to a variety of nearby options, with the Health Department providing assistance in transferring medical records to their chosen providers.

This realignment represents the Health Department's broader strategy to enhance public health services in Prince George's County through innovative partnerships and by addressing the dynamic needs of its residents.

(Nov. 26, 2024)-Health-conscious community members in Prince George's County visited Senior Health and Wellness Day, a resource fair held by Community Health at MedStar Southern Maryland Hospital Center and Clinton Baptist Church on Saturday, Nov. 23. At the event, MedStar Health clinicians offered on-site prostate cancer screenings for eligible men at no cost. Participants were also not asked for their insurance information.

Prostate cancer effects Black men living in Prince George's County at an alarmingly high rate. They are diagnosed almost 40% more often than U.S. men on average and die from the disease almost 80% more often, according to county statistics. Physicians currently recommend all men over age 50 receive a digital rectal exam screening. For black men, or men with a family history, screenings are recommended starting at age 40. Chile Ahaghotu, MD, vice president of Medical Affairs at MedStar Southern Maryland Hospital Center and a boardcertified urologist, provided the free

screenings at the church.

"The good news is that when prostate cancer is detected early, it is highly treatable," Dr. Ahaghotu said, "That's why we

## To Be Equal: Malcolm X Lawsuit Is an Opportunity for NYPD & Federal Law Enforcement to Draw the Curtain on an Era of Corruption and Injustice

"For decades, [U.S. government agencies and the NYPD] viewed Black activism as a threat to national security, resulting in the unchecked targeting of prominent leaders, including Dr. Martin Luther King Jr. and Marcus Garvey. This lawsuit seeks accountability for the systemic negligence and intentional actions that deprived Malcolm X's family and the world of his life and legacy."

Six days before Malcolm X was gunned down

at the Audubon Ballroom in New York City, an undercover NYPD detective told the department he'd seen "a dry run" of Malcolm X's assassination, which he believed would happen on the upcoming Sunday.

The next day, two members of Malcolm X's security team were arrested and detained in connection with a bogus plot to bomb the Statue of Liberty.

Malcolm X's daughters charged in a lawsuit filed [recently] that the arrests were coordinated by the NYPD and federal law enforcement agencies "to weaken Malcolm X's security, which knowingly facilitated his assassination."

In a letter written in 2011 and unveiled after his death in 2020, the undercover officer who drew the men into the plot wrote, "It was my assignment to draw the two men into a felonious federal crime, so that they could be arrested by the FBI and kept away from managing Malcolm X's Audubon Ballroom door security on February 21, 1965."

The lawsuit pulls together years of systemic and institutional corruption within the NYPD, the FBI, and the CIA. A swift settlement would allow these agencies to draw the curtain on an ugly period of rank injustice and usher in a new era of integrity and decency.

Accusations of conspiracy and corruption have surrounded Malcolm X's assassination from the moment the bullets were fired. Earl Grant, a close associate, wrote of the immediate aftermath, "Here were New York City policemen, entering a room from which at least a dozen shots had been heard, and yet not one of them had his gun out! As a matter of absolute fact, some of them even had their hands in their pockets."

Two of the men who were convicted of the murder, Muhammad A. Aziz and Khalil Islam,

were exonerated last year after an investigation by the Manhattan District Attorney's Office determined that the NYPD and FBI withheld key evidence that likely would have led to their acquittal

Mujahid Abdul Halim, who confessed to the murder at trial, has always insisted Aziz and Islam were innocent. He initially declined to name his co-conspirators but later identified them as Leon Davis, Benjamin Thomas, and two men whose full names he did not know, "William X" and "Wilbur or Kinly."

The Manhattan D.A.'s investigation did not confirm the guilt of those men or outline a conspiracy among local and federal agencies. But the lawsuit claims the reason Malcolm X was denied entry into France 12 days before his assassination was that French authorities had learned of a CIA plot to murder him and feared he would be "liquidated" on French soil.

The CIA's unofficial motto is the Biblical verse "And ye shall know the truth and the truth shall make you free." Until these agencies acknowledge the truth surrounding Malcolm X's assassination, we cannot truly claim to be free.

## **ChildWatch: Saying Grace**

During the Thanksgiving season I often share the description of an editorial cartoon my father kept pinned up in the vestibule of our church that made a deep childhood impression on me I have never forgotten. It was a black and white drawing by the Pulitzer Prize-winning artist Herblock that was originally published in the Washington Post in October 1947. The picture showed a group of welldressed, happy people, sitting at a banquet table overflowing with place settings, goblets, and so much food the table cannot hold any more: a roast,

gravy boats, bread and butter, covered dishes, heaping platters of sides. Hovering behind them and filling the rest of the image is a crowd of gaunt, wide-eyed hungry children dressed in rags. There are too many of these skeletal figures to count; the starving masses go on and on into the distance. Back at the table, one of the dinner guests is speaking cheerfully to his smiling companions. The caption reads: "Shall we say grace?"

In some houses Thanksgiving dinner will look a little like that cartoon, with tables overflowing

too many families, Thanksgiving will be like any other meal: not a time of plenty but a time of want. In his final book, Where Do We Go from Here: Chaos or Community? Dr. Martin Luther King, Jr., asked: "Why should there be hunger and privation in any land, in any city, at any table, when man has the resources and the scientific knowhow to provide all mankind with the basic necessities of life? . . . Ultimately a great nation is a compassionate nation. No individual or nation can be great if it does not have a concern for 'the least of these." We are reaching another crossroads when we must decide whether Dr. King's definition of a truly great nation will stand as our goal, or whether other loud voices and competing visions will allow the gulf between the haves and have-nots to grow, reveling in their own successes while millions of others are left outside and left behind.

Some years ago, Children's Defense Fund pro bono advertising partner Fallon Worldwide created a campaign for CDF that very simply updated the

## **Season With Online Tools and Key Reminders**

WASHINGTON (IR-2024-297, Nov. 22, 2024)—As the nation's tax season approaches, the Internal Revenue Service is reminding people of simple steps they can take now to prepare to file their 2024 federal tax returns.

This reminder is part of the IRS's "Get Ready" campaign to help everyone prepare for the upcoming filing season in early 2025.

"Our focus at the IRS continues to be on making tax filing easier and more accessible for everyone," said IRS Commissioner Danny Werfel. "We've added more digital tools to help taxpayers. But as tax season quickly approaches, the IRS reminds taxpayers there are important steps they can take now to get ready for 2025. From reviewing withholding to signing up for an IRS Online Account, there are multiple ways for people to help make the 2025 filing season easier."

As the IRS continues its historic transformation work, the agency continues introducing new online tools as well as expanding and updating other digital tools. These are designed to help taxpayers and make tax filing easier.

#### Access IRS Online Account for helpful information

Taxpayers can create or access their IRS Online Account, where they can find all their tax related information for the 2025 filing season. New users will need to have a photo ID ready to verify their identity. Through their IRS Online Account, taxpayers can:

- View key details from their most recent tax return, such as adjusted gross income.
- Request an Identity Protection PIN.
- Get account transcripts to include wage and income records.
- Sign tax forms like powers of attorney or tax information authorizations.
- · View and edit language preferences and alternative media (such as braille, large print, etc.).
- Receive and view over 200 IRS electronic notices.
- View, make and cancel payments.
- Set up or change payment plans and check their balance.

### Gather and organize tax documents

Having well-organized tax records can make filing a complete and accurate return easier and help avoid errors that can delay refunds. This may also help identify deductions or credits that may have been overlooked.

Most income is taxable, including unemployment compensation, refund interest and income from the gig economy and digital assets. Taxpayers should watch for and gather essential forms, such as Forms W-2, Wage and Tax Statement, and other income documents.

It's also important to notify the IRS of any address changes and the Social Security Administration of any legal name changes.

### Check withholding before the end of 2024

The IRS Tax Withholding Estimator on IRS.gov can help tax-

payers make sure the correct amount of tax is withheld from their paychecks. This tool is especially useful for individuals who owed taxes or received large refunds last year, or those who have experienced life changes such as marriage, divorce, or the welcoming of a child. Taxpayers who need to adjust their withholding can update their information with their employer using Form W-4, Employee's Withholding Allowance Certificate.

Time is running out to make changes for 2024, as only a few pay periods remain in the year. Taxpayers need to act quickly to make any adjustments.

## Get refunds faster with direct deposit

The fastest and most secure way to receive a tax refund is through direct deposit. Taxpayers can direct their refund to a bank account, banking app or reloadable debit card by providing their routing and account numbers. If the routing and account number cannot be located, taxpayers should contact their bank, financial institution or app provider.

According to Treasury's Bureau of the Fiscal Service, paper refund checks are 16 times more likely to be lost, misdirected, stolen or uncashed compared to those paid using direct deposit.

Individuals without a bank account can explore options for opening one through FDIC-insured banks or a credit union using the National Credit Union Locator tool. Veterans can use the Veterans Benefits Banking Program to find participating financial institutions.

### Volunteer to help others with their taxes

The IRS and its community partners are seeking volunteers from around the country to join the Volunteer Income Tax Assistance (VITA) and Tax Counseling for the Elderly (TCE) programs. These programs offer free tax preparation services to eligible taxpayers. Interested individuals can learn more and sign up by visiting IRS.gov.

### Helpful IRS resources and online tools

IRS.gov is a valuable resource for taxpayers, offering a variety of online tools like the Individual Online Account available 24/7. These tools help individuals file and pay taxes, track refunds, access account information and get answers to tax questions. Taxpayers are encouraged to bookmark these resources for easy access.

### **Choosing a tax professional**

Tax professionals play an essential role in the U.S. tax system. Certified public accountants, Enrolled Agents, attorneys and others without formal credentials are just a few of the professionals who help taxpayers file their returns accurately. It is important to choose a professional who is skilled and trustworthy.

Most tax return professionals provide great service but picking the wrong one can hurt taxpayers financially. The IRS offers tips for choosing a tax preparer.

People can use the IRS Directory of Federal Tax Return Preparers with Credentials and Select Qualifications to find qualified professionals.

## Ask Rusty: **Am I Entitled to More Social Security From my Ex-husbands?**

Dear Rusty: I am 76 years old and a retired high school counselor/teacher. I was married to my first husband from 1968 until 1981. He is still living, and he remarried two more times and, I believe, he is currently divorced. He is 77 years old. His income was always much higher than mine. I was married to my second husband from May 1989 until we divorced in April 2017. My second husband died in June 2023. What I wonder is if I am entitled to receive Social Security benefits based upon the income of either of my exhusbands? Signed: Twice Divorced Spouse

Dear Twice Divorced: Divorced spouses are entitled to the same benefits as a current spouse if their marriage lasted at least 10 years which, in both cases, yours did. The other caveat is whether your own SS retirement benefit is less than you are entitled to from either of your ex-husbands. If your own SS retirement benefit is less, then you will get an incremental amount on top of your own SS retirement to bring your total monthly benefit up to your spousal (or surviving spouse) entitlement.

Since your first husband is still living, it is likely that your best financial option is to claim a surviving ex-spouse benefit from your deceased 2nd husband. The reason is that survivor benefits from husband #2 are based on his actual benefit at his death, whereas benefits from a living ex-spouse (husband #1) are based upon his full retirement amount. In other words, it is likely that 100% of deceased husband #2's benefit at his death is more than 50% of living husband #1's current benefit at his full retirement age (FRA)

It is, of course, possible that 50% of your first husband's FRA entitlement is more than 100% of your second husband's benefit at death, in which case your ex-spouse benefit from your first husband could be more. The only way to sort this out is to contact Social Security (1.800-772-1213) to make an appointment to apply for surviving ex-spouse benefits from your deceased second husband. Explain that your first ex-husband is still living, and that you are unsure of what your benefits are as your first husband's ex-spouse. Social Security will be able to determine from their records which one provides you with a higher benefit amount (provide each husband's Social Security number when you call). As I said, your best financial option will likely be to take your survivor benefit from your deceased second ex-husband (note, however, if your first ex-husband also dies before you, you can subsequently file for a survivor benefit from him, if that is more than you are getting from your second husband's record).

The Road to Careers grant program represents one of the largest commitments to transportation-related workforce development in the country and is made possible through a close partnership with the Maryland Department of Labor, the Maryland Department of Transportation, and the Federal Highway Administration. Grants will fund workforce training and support services, creating a new generation of workers to build the state's critical transportation infrastructure. The program will invest \$4 million annually over six years. "When we voted for the historic infrastructure bill, we knew the importance of ensuring that new federal investments in our transportation infrastructure would be complemented by investments in our

This historic investment couples time-tested training models like apprenticeship with critical supports like childcare, access to counseling, or basic needs like uniforms," said Maryland Department of Labor Secretary Portia Wu. "We thank Secretary Wiedefeld and MDOT for their forward-thinking leadership and partnership on this effort." Applications are due February 28, 2025 and grants will begin in May 2025. Awards are capped at \$500,000.

## **Robots to the Rescue of EarthTalk**<sup>®</sup> Q&A the Environment?

Dear EarthTalk:

*Is it true that using robots* can help us reduce our carbon footprint? This sounds great but what are the tradeoffs of increased utilization of robots? -Robert Pardue, Reno, NV

Robots are increasingly integral to addressing environmental challenges, from cleaning oceans to aiding reforestation. For instance, Clearbot removes some 15 liters of oil and 200 kilograms of trash from oceans daily, mitigating marine pollution. Robots also accelerate tree planting, restoring forests faster and more precisely than humans. In cities, robots are helping lower carbon footprints. Delivery robots can cut road congestion by 29 percent and reduce emissions by 16 percent compared to traditional vehicles. Often powered by renewable energy like solar, these robots further minimize environmental impact.

Similarly, robots are making an impact in transportation. Electric vehicles equipped with self-driving features are becoming more common, following Tesla's lead. Since EVs run on electricity rather than gas, they help reduce greenhouse gas emissions. Many of these au-

tonomous vehicles also include features like automatic braking, lane detection and speed control, which can enhance safety and efficiency on the road.

Robots have also made their way into industrial settings, where they improve efficiency and help cut down carbon emissions. A 2022 study found that the use of robots in manufacturing has enhanced carbon emission reduction efforts across 35 countries. By automating repetitive tasks, robots can help reduce errors and improve the overall energy efficiency of production processes.

However, the environmental benefits of robots come with significant tradeoffs. Most robots rely on batteries made from lithium and cobalt, which are not evenly distributed around the world. Mining these materials is resource-intensive and often leads to environmental degradation. The extraction process consumes large amounts of energy, releases air pollutants and can contaminate local water supplies.

Once in use, robots-like any other technology-are subject to wear and tear. When they break or become outdated, they add to the growing problem of electronic waste. The faster pace of production enabled by robots also fuels consumer demand, further increasing waste. And these impacts often hit poorer nations hardest, as they are disproportionately affected by pollution and resource depletion.

Long term, as robot designs improve and new technologies are developed, some of these challenges may be mitigated. Companies like AI for Good, Echo Tech Daily and Redwood Materials are developing more sustainable robots. But for now, it's important to weigh the benefits and tradeoffs carefully. While robots hold great promise for helping us reduce our carbon footprint, they are far from a perfect solution.
