

Gov. Moore Forecasts Huge Cuts to the State Budget This Spring

As the General Assembly starts its new legislative session this week, one big thing is on the mind of Maryland lawmakers: fixing a massive budget deficit that may call for tax hikes and cuts to beloved pro-

Gov. Wes Moore said on opening day of the General Assembly that a "season of hard choices" is beginning, and that balancing the budget is the top priority in the coming weeks and months. He said he would put forth a budget proposal that includes \$2 billion in cuts.

"I inherited a structural deficit that is the largest we have seen in two decades," Moore said at a panel hosted by The Daily Record. "We didn't actually address the structural issues."

One issue that Moore and other Maryland lawmakers are facing with Trump taking office is a potential rollback of federal dollars flowing into the state, a reality that would make eliminating the \$3 billion deficit all the more challenging.

"Frankly, we have been building budgets based on the fact that trillions of dollars were coming from the federal government," Moore told Daily Record journalist Jack Hogan. "That's not

happening anymore."

Speaking at the same event, Senate President Bill Ferguson echoed Moore's commitment to balancing Maryland's finances, adding that addressing the deficit will be the number one priority for the General Assembly.

"The budget is going to drive a lot of the decision making," said Ferguson, who represents Baltimore City. "I think the expectation for the 2025 session is, we've got to figure out the budget first and foremost, and everything else is going to be secondary to that."

The legislative session opened Wednesday with pomp and circumstance, with Moore addressing both chambers and

members publicly praising their parties' leaders. Ferguson and House Speaker Adrienne Jones were reinstalled as Senate majority leader and House speaker, to shouts and applause from their supporters.

All the while, the grim specter of the deficit—and the significant measures that will have to be taken to address it hung over the proceedings.

Moore said that many of the planned cuts will be focused on making government operations more efficient.

"There is a lot that government can do to make sure we are tightening our belt, that we are being more efficient, that we are being swifter and faster,"

Moore said.

The second part of improving efficiency, he added, is to ensure that funds flow towards goals and programs that are "effective and sustainable," leaving those that don't match that description on the cutting room

One area that could potentially see cuts is transportation.

Michael Sakata, the president and CEO of the Maryland Transportation Builders and Materials Association, said he believes that such cuts would run counter to the state's goals of building a more robust econ-

"We need to remain competitive by investing in transportation," Sakata told Capital News Service, saying that, in a post-COVID world, people are commuting to work from farther away. They rely on efficient highways and infrastructure to get to their jobs, he said.

Sakata is not the only one with concerns about Maryland's potential cutbacks.

Moore's \$2 billion dollars of planned cuts still leave a third of the deficit untouched, without a clear plan as to how it will be addressed. Maryland Republicans are concerned that Democrats may implement tax hikes to address the remaining \$1 billion.

Speaking at a news conference for Republican leadership, Senate Minority Leader Stephen Hershey Jr. said that Republi-

MARTIN LUTHER KING JR. DAY

Martin Luther King Jr. Day (officially Birthday of Martin Luther King, Jr., and often referred to in shorthand as MLK Day) is a federal holiday in the United States observed on the third Monday of January each year. King was chief spokesperson for nonviolent activism in the Civil Rights Movement, which protected racial discrimination in federal and state law and civil society. The movement led to several groundbreaking legislative reforms in the United States.

Born in 1929, Martin Luther King Jr.'s actual birthday is January 15 (which in 1929 fell on a Tuesday). The earliest Monday for this holiday is January 15 and the latest is January 21. The Monday observance is similar for those federal holidays which fall under the Uniform Monday Holiday Act.

The campaign for a federal holiday in King's honor began soon after his assassination in 1968. President Ronald Reagan signed this holiday into law in 1983, and it was first observed three years later on January 20, 1986. At first, some states resisting observing the holiday as such, giving it alternative names or combining it with other holidays. Official observance in each state's law as well as federal law occurred in 2000.

Proposals: The idea of Martin Luther King Jr. Day as a holiday was promoted by labor unions in contract negotiations. After King's death, Representative John Conyers, a Democrat from Michigan, and Senator Edward Brooks, a Republican from Massachusetts, introduced a bill in Congress to make King's birthday a national holiday. The bill first came to a vote in the U.S. House of Representatives in 1979. It fell five votes short of the number needed for passage. Two of the main arguments mentioned by opponents were that a paid holiday for federal employees would be too expensive, and that a holiday to honor a private citizen would be contrary to longstanding tradition (King had never held public office). Only two other figures have national holidays in the U.S. honoring them: George Washington and Christopher Columbus. Information from Wikipedia.

To Be Equal:

Trump Is Poised to Launch an Unprecedented Attack on Racial Justice. The National Urban League Is Ready to Fight Back

"Every nation's history includes unsettling truths that many would prefer to forget or deny. But true patriotism demands confronting the truths of our history—no matter how embarrassing or dishonorable—and undertaking the difficult work of learning from the lessons of our past in order to move forward. For the United States, that work requires reckoning with our shameful legacy of racial subjugation of Black people in this country—from slavery and Jim Crow to mass incarceration and police violence—as well as our long history of express discrimination against other people of color, women, and LGBTQ persons.

Without uninhibited discussion and examination of that legacy, we are ill-equipped as a nation to address its ongoing manifestations in present-day forms of discrimination and bias."

—National Urban League v. Trump

At the current rate of progress, it will take between 100 and 300 years for Black Americans to achieve parity with white Americans.

First annually and now biannually, the National Urban League publishes the Equality Index, a calculation of the social and economic status of African Americans relative to whites. Rooted in the Three-

Fifths Compromise of 1787, which counted enslaved African Americans as "three-fifths" of a person, the Index would be 100% under full equality. Currently 75.7%, the Index has moved less than 3% in 20 years, indicating a 180 year wait to achieve parity.

That squares with the findings of a McKinsey study showing it will take between 110 and 320 years at for "Black Americans to reach a level of economic prosperity and quality of life that's on par with that of their White neighbors."

President-elect Donald Trump and his allies are determined to make sure that it takes even longer.

At the end of his first term, Trump issued an executive order banning policies that promote diversity, equity, and inclusion for federal agencies, contractors, and grant recipients. The National Urban League immediately filed a lawsuit; Trump lost reelection and President Biden overturned it immediately upon taking office.

This time around, Trump isn't waiting to start stamping out racial justice initiatives. He's vowed to rescind President Biden's Executive Order On Advancing Racial Equity, issued on his first day in

Seizing on the widely-accepted myth that increasing diversity is synonymous with "anti-white discrimination," the Trump administration plans to use civil rights laws to reinforce white privilege in every facet of society, public and private. Pete Hegseth, Trump's nominee for Defense Secretary has promoted the racist fallacy that the long-overdue elevation of Black officers to senior leadership positions compromises military readiness.

In fact, Trump's proposed cabinet includes only one Black member, a former NFL player whose only qualification to head the Department of Housing and Urban Development is his history of opposing affordable housing, protection for poor tenants, and aid for the homeless.

Trump will eliminate federal funding for any school that promotes racial equity or confronts the reality of racism in the nation's history. He has even vowed to direct the Department of Justice to pursue federal "civil rights cases" against them.

He plans to resurrect the failed 1776 Commission, which historians reviled as a plot to "elevate ignorance about the past to a civic virtue.

Hoping to avoid attacks from the incoming administration and its most fanatical defenders, many private corporations are retreating from their commitment to DEI. The board of Costco, in contrast, recently rejected an anti-DEI shareholder proposal.

While post-election surveys show that Trumps' election was largely a misguided reaction to the cost of groceries, Trump and his allies have taken it as an endorsement of their every vicious and bigoted policies. Americans overwhelmingly support corporate diversity policies. President Biden's administration—like most diverse institutions, was more innovative, adaptable, resilient, and able to solve problems more quickly because of its diversity.

If the incoming administration doesn't realize the benefits of DEI early on, the National Urban League and our civil rights allies are on hand to hold it to account.

Families Salute Maryland Women of the "Six Triple Eight"

CATONSVILLE, Md.—Nineserved during World War II in the 6888th Battalion, the prenow the subject of the blockbuster film "The Six Triple Eight."

After decades of hearing their teen women from Maryland stories only as family lore, if they heard them at all, the families of these Marylanders are dominantly Black postal unit watching those stories come

alive—and enjoying the longawaited recognition for their

"I have wanted my mother and my aunt to be honored and to be appreciated for a long time," said Karen Taylor, "and now because of the Tyler Perry

movie the world knows what they accomplished."

Although not main characters in Perry's movie, Taylor's mother and aunt were both members of the postal unit featured in the film.

The Six Triple Eight, officially the 6888th Central Postal Directory Battalion, deployed to Europe for roughly a year during World War II. Some 855 women came from across the U.S. to process mail in the European theater of war.

They were a twice-segregated unit, as women served separately from men at the time, and women of color served separately from white women.

The film release prior to Christmas has reanimated discussion of the unit, bringing their accomplishments into public consciousness. For descendants and family members, it's a culmination of a multi-year effort to bring awareness to their family's military service.

Taylor, a 78-year-old retired dental hygienist, points to her living room wall lined with pictures of family members in her Catonsville apartment. Several items, including pictures, a U.S. flag, a certificate and a movie poster indicate a connection to the 6888th.

"These women were fighting for us." Taylor said. "Even if someone tells you you can't do something, you don't let it go at that. You keep on going and prove that you can."

Taylor says that's how her mother raised her.

Taylor's mother, Vivian Elzie Taylor, was one of 19 women

who enlisted in Maryland and deployed with the 6888th. After serving in Europe and meeting and marrying her husband, Elyseo J. Taylor, in Paris, she settled in Salisbury, Maryland.

She and her husband, a tanker in the first Black tank battalion, eventually divorced. Elzie Taylor

Ask Rusty:

About Investing Social Security Money in the Stock Market

Dear Rusty: For most folks collecting Social Security, you get back what you put in within 3–5 years, so for those that scream—"SS is not an entitlement, it is my money"—that is not entirely accurate beyond 3–5 years. For me personally 4.4 years is the number. But had I been able to invest that money over the 43 years I worked at a modest 6% interest, I expect the amount would have been a lot more. And of course, the stock market averaged 9.5% over that time. Perhaps Social Security should invest in the stock market instead of U.S. Government treasury bonds. Signed: Interested Observer

Dear Observer: You bring up a point we frequently hear—that if, instead of paying into Social Security, I had invested the same money in the stock market I would have gotten more. That, of course, might be the case if you had the unwavering discipline to religiously invest the equivalent amount in the market, avoiding the temptation to use that investment for any other reason. And life is full of good reasons—financial emergencies, for example, or the simple temptation to buy something desperately needed, or just occasionally skipping a month to pay bills. Also, the stock market is notoriously volatile, which can create substantial angst for investors who are faint of heart. The fact is that Social Security provides guaranteed financial growth from the age of eligibility (normally 62), up to age 70 when the maximum benefit is attained. Benefits claimed at one's full retirement age are about 24%-32% more than if taken at age 62 (depending on full retirement age), and benefits taken at age 70 are about 75% more than benefits taken at age 62. And that is guaranteed growth for those with the patience to wait longer to claim.

You may recall that the idea of investing Social Security reserves in the stock market has been floated a few times in previous years, but accompanying risks made Congress essentially unwilling to even entertain the idea. It has always been a political "hot potato" and those who suggest it are usually castigated for wanting to "give SS money to Wall Street," so I expect it is unlikely to happen. Guess we'll need to be satisfied with the interest on those Special Issue Government Bonds (which, by the way, returned about \$67 billion to the Social Security Trust Fund in 2023). FYI, average interest rate for new deposits to the Trust Fund in 2023 was 4.1%, and the overall effective rate of return on all Trust Fund assets was 2.4%.

Social Security has some issues and will face some financial difficulty in less than a decade unless Congress enacts program reform soon. But it is a program which most seniors rely on for a major part of their retirement income and one which keeps over 22 million Americans out of poverty. Here at the AMAC Foundation, we strongly advocate for sensible Social Security reform and we're very optimistic about the program's future. But Congress needs to act soon to avoid a cut to everyone's Social Security amount in about 2033.

went to teach art at the all-Black Salisbury High School in Maryland's then-segregated school sys-

From a segregated army to a segregated school system, Elzie Taylor's mid-century career was emblematic of the challenges Black women faced in Maryland and around the country.

She passed a lesson on to her daughter about persevering in the face of obstacles.

"My mom pushed me," Taylor said. "She made

After her mom died, Taylor began exploring the military oral history her mother had shared

with her. It wasn't just her mother who served. Taylor's aunt, Marian Elzie Wilson, enlisted in Pennsylvania and also deployed with the 6888th.

The more she learned, she said, the more she understood the groundbreaking territory the group charted.

And she wasn't the only one.

Vashti Murphy Matthews, from Baltimore's multi-generational publishing family of AFRO American Newspaper, also served overseas with the 6888th.

She was a taciturn woman who—despite a drill sergeant-like leadership style—never spoke about her time in the army, according to her daughter, Betty Schuler.

"Had it not been for me finding some pictures, we would never have known that she served at all," said Schuler. "Not one word did she speak."

Schuler and her cousin first learned about the 6888th when a monument was being erected in honor of the unit. Researchers and fundraisers were reaching out to descendants and media organizations, which led them to Schuler and her cousin, Frances Murphy Draper, CEO and publisher of the family business.

The Buffalo Soldier Educational and Historical Committee created a monument for the 6888th in Fort Leavenworth, Kansas, outside of Kansas City, in 2018.

A few years later, Congress passed legislation

awarding the unit the Congressional Gold Medal. Maryland Gov. Wes Moore even designated March 9 as a day honoring the 6888th in Maryland.

But it wasn't until the movie that the unit really caught people's attention. Draper compares the Six Triple Eight to other overlooked stories about people of color.

"I think it also speaks to the 'argument' about the need to really teach African American history," said Draper. "There's a whole history of people, and the more we understand about people ... the more we understand that we have more in common than we have different."

EarthTalk® Jimmy Carter's Q&A Environmental Legacy

Dear EarthTalk: What is Jimmy Carter's en-

vironmental legacy?
—B.N., Athens, GA

Jimmy Carter, the 39th U.S. President, made a lasting impact on environmental policy. His robust initiatives to protect natural resources and advance clean energy established the foundation for environmental policy in subsequent decades. Despite obstacles, his efforts in land preservation, energy efficiency and climate activism still impact environmental policy in the present day.

One of Carter's most significant actions, a symbolic one, was installing solar panels on the White House. And he signed the National Energy Act, which reduced U.S. dependence on foreign oil and encouraged the use of alternative energy sources. "The energy crisis is real. It is worldwide. It is a clear and present danger...' Carter stated during his presidency, emphasizing the urgency of moving to sustainable energy. Carter also created the Department of Energy in 1977 to consolidate management and energy policy. The move displayed his foresight in addressing energy security and climate issues. This laid out the groundwork for the renewable energy sector's growth in subsequent decades.

Carter's dedication to conservation was equally effective. His administration included multiple wildlife reserves, national parks and public lands in the federal portfolio. Specifically, he enacted the Alaska National Interest Lands Conservation Act in 1980, which protected over 100 million acres of Alaska wilderness, enlarged the National Park System and protected priceless ecosystems for future generations. Reinforcing existing environmental codification was another order for Carter. He reinforced the Clean Air and Clean Water Acts, and in 1980, signed the Superfund law to

clean up hazardous waste sites. After leaving office, Carter continued to work for the environment. Through the Carter Center, he promoted sustainable farming and clean energy. His work with Habitat for Humanity promoted affordable and sustainable housing as a foundation of environmental and social justice. "Habitat has successfully removed the stigma of charity by substituting it with a sense of partnership," Carter voiced. Carter's environmental vision faced difficulties. Economic struggles limited the scope of some initiatives. Additionally, President Reagan removed the White House solar panels, indicating a retreat from Carter's vision. But his cutting-edge advocacy inspired subsequent efforts on climate change and conservation.

Jimmy Carter's environmental legacy serves as a reminder that fearlessness and long-term vision are important in addressing today's ecological challenges. His leadership continues to inspire. Ultimately, his efforts underscore the mutuality of protecting the environment, sustainable development, and social justice.


