# **Governor Moore Announces \$1 Billion** "Capital of Quantum" Initiative

COLLEGE PARK, Md. (Jan. 15, 2025)-Gov. Moore is pledging to make Maryland the "quantum capital of the world," proposing a significant investment into the industry of super-fast computing amid a budget crisis in the state.

Speaking at the College Park headquarters of IonO, a leading quantum computing company, Moore said Tuesday he believes quantum is one of the industries in which Maryland has a competitive advantage, industries that could help grow an economy he said has been stagnant for too long.

"I refuse to have, in this moment, with the talent we have in the field, for Maryland to be a state that is just simply going to manage decline," Moore said. "Maryland, if we grow, we win. We're going to grow."

In his address to the crowd, which included representatives from IonQ, the University of Maryland and other industry leaders, Moore announced a \$27.5 million investment in the new "Capital of Quantum" initiative. Moore described the project as a joint venture between the state, the University of Maryland, IonQ and "other partners in the quantum computing space."

Moore described the goal of the investment as a simple one: "to make Maryland the capital of quantum of the world."

The announcement of the initiative follows a week of financial volatility in the quantum industry. Stock for IonQ and other companies in the field have seen dramatic rises and falls over the past several days

after figures like Nvidia CEO Jensen Huang and Meta CEO Mark Zuckerberg questioned the idea of quantum computing being ready in the near future.

Despite this, Moore believes investing in the industry is a good short-term bet, and an even better one in the long-term.

"I think this is actually a smart bet for our GDP growth early," Moore told CNS in a gaggle with reporters, "and I think it's an incredibly smart bet for our long-term prospects of having something that Maryland can really pride itself on as having one of the leading spaces in the industry."

Quantum computing, a rapidly-emerging industry in the technology space, involves using quantum mechanics to produce answers to problems far faster than current computers can. The applications of such technology are wide-ranging, including artificial intelligence, pharmaceutical research and cybersecurity.

"Quantum computing doesn't just bend reality," Lt. Gov. Aruna Miller said at IonQ headquarters. "It redefines it, solving prob-

#### Remembering the Challenger

On January 28, 1986, the space shuttle Challenger broke apart shortly after it lifted off from the Kennedy Space Center in Florida, killing all aboard.

Among the seven crew members was Christa McAuliffe, a schoolteacher chosen by NASA as the agency's first citizen astronaut. The resulting public fascination with her made sure the launch was witnessed by millions, including schoolchildren in their classrooms who tuned in to watch it live on TV.

I watched the lift-off. I saw it break apart and crash.

There's no way I can describe the horror across the U.S. But here in Morningside it was personal—Christa McAuliffe had been a teacher at Benjamin D. Foulois Middle School.

Christa had completed her MA at Bowie State College and

taught English and social studies for seven years in Prince George's, three years at Foulois Middle School, 1971 to 1973. Meanwhile, her husband Steve was a law clerk for then-State Senator Steny Hoyer.

Christa's mission continues now at the Christa McAuliffe Planetarium which was erected in her memory. In April 1988, the New Hampshire Legislature appropriated funds to build the Planetarium. Groundbreaking took place October 26, 1988.

lems in ways we never, ever thought possible."

Along with the focused spending in quantum computing, Moore also announced a larger \$750 million investment in "economic

growth and workforce development," with a focus on leveraging the assets that Maryland has to grow the state's economy.

"Oftentimes," Moore said, "we have been asset-rich and strategy-poor. We haven't prioritized the areas that need to be prioritized. Well, today that changes."

# **A Definition of Greatness**

you want to be recognized—wonderful. If you want to be great—wonderful. But recognize that he who is greatest among you shall be your servant. That's a new definition of greatness. And this morning, the thing that I like about it: by giving that definition of greatness, it means that everybody can be great, because everybody can serve. You don't have to have a college degree to serve. You don't have to make your subject and your verb agree to serve. You don't have to know about Plato and Aristotle to serve. You don't have to know Einstein's theory of relativity to serve. You don't have to know the second theory of thermodynamics in physics to serve. You only need a heart full of grace, a soul generated by love."

As we celebrate the national holiday honoring Dr. Martin Luther King, Jr., which coincides with Inauguration Day in Washington, D.C., this year, it is an opportune moment to return to Dr.

"If you want to be important—wonderful. If King's definition of greatness. The well-known words above are from Dr. King's sermon "The Drum Major Instinct," delivered at Ebenezer Baptist Church in Atlanta on February 4, 1968. Dr. King was explaining that we all start out with the ingrained instinct to be "drum majors": everyone wants to be important, to be first, to lead the parade. Watch a group of small children pushing and shoving to form a line and you'll see this instinct in action. But Dr. King correctly pointed out that too many people never outgrow it—and by placing value on being the most powerful or famous or the wealthiest or best-educated, we forget one of the Gospels' and life's largest truths: the real path to greatness is through service.

This is one of the key lessons we should teach children and young people about Dr. King. Many of them have just studied Dr. King in school in the days leading up to his birthday—at least, those whose schools allow lessons on Dr. King's

life and legacy. Young people today often see him as a history book hero, a larger-than-life, mythical figure. But it's crucial for them to understand Dr. King wasn't a superhuman with magical powers, but a real person. He gave us a blueprint for true servant-leadership everyone

I first heard Dr. King speak in person at a Spelman College chapel service during my senior year in college. Dr. King was just 31, but he had already gained a national reputation during the successful Montgomery Bus Boycott five years earlier. He became a mentor and friend. Although I do remember him as a great leader and a hero, I also remember him as someone able to admit how often he was afraid and unsure about his next step. It was his human vulnerability and ability to rise above it that I most remember. "If I Can Help Somebody Along the Way" was his favorite song. He was an ordinary man who made history because he was willing to stand up and serve and make a difference in extraordinary ways, and children and young people need to know that they can and must make a difference too. Everybody can be great, because everybody can serve.

Towards the end of this sermon, Dr. King told the congregation he sometimes thought about his own death and funeral. He said when that day came he didn't want people to talk about his Nobel Peace Prize or his degrees or hundreds of awards: "I'd like somebody to mention that day that Martin Luther King, Jr., tried to give his life serving others. I'd like for somebody to

say that day that Martin Luther King, Jr., tried to love somebody. I want you to say that day that I tried to be right on the war question. I want you to be able to say that day that I did try to feed the hungry. And I want you to be able to say that day that I did try in my life to clothe those who were naked. I want you to say on that day that I did try in my life to visit those who were in prison. I want you to say that I tried to love and serve humanity. Yes, if you want to say that I was a drum major, say that I was a drum major for justice. Say that I was a drum major for peace. I was a drum major for righteousness. And all of the other shallow things will not matter. I won't have any money to leave behind. I won't have the fine and luxurious things of life to leave behind. But I just want to leave a committed life behind. And that's all I want to say."

Dr. King was assassinated two months to the day after delivering this sermon. But a recording of "The Drum Major Instinct" was played at his funeral at Ebenezer Baptist Church, and many people think of these moving words in Dr. King's voice as his own eulogy. He knew how he wanted to be remembered. A very similar emphasis on service was echoed in the recent national tributes to President Jimmy Carter. Who among us today will be remembered as servant-leaders, and who will be remembered as drum majors?

Servant-leadership remains the path to true —January 17, 2025

Trump has vowed that on his first day in office, he will revoke President Biden's executive order on racial equity, and pursue the dismantling of diversity, equity, and inclusion initiatives both within the federal government and among private

Project 2025, the policy blueprint Trump is expected to follow, calls for the Department of Justice's Civil Rights Division to "investigate and prosecute all state and local governments, institutions of higher education, corporations, and any other private employers" with diversity, equity, and inclusion policies. It calls for references to "sexual orientation and gender identity" to be deleted from all federal rules, LGBTQ workplace discrimination protections to be sharply limited, and a ban on transgender troops in the U.S. armed forces.

The Demand Diversity Roundtable represents a refusal to remain silent in the face of an unprecedented assault on DEI measures, and a commitment to fostering unity, resilience and proactive leadership in defense of equal opportunity for all.

America's strength lies in its diversity, and abandoning DEI would endanger the nation's progress and future.

While Trump professed to know nothing about Project 2025 during his campaign, as President Elect he has selected its authors and influencers for key roles in his administration. The agenda is alarmingly hostile to any measures it designates as "woke"—a term the "anti-woke" movement has defined as "the belief there are systemic injustices in American society and the need to address them." The movement holds that acknowledging discrimination is, in itself, discrimination.

Several organizations that have been designated hate groups by the Southern Poverty Law Center are among Project 2025's advisory board, including Alliance Defending Freedom, infamous for restricting access to the abortion pill and support for anti-LGBTQ+ policies, and Center for Immigration Studies, known for providing a platform for racist writers along and associating with white nationalists.

The incoming administration's policies. aligned with frameworks like Project 2025. threaten to undermine principles of equal opportunity and roll back progress toward a multiracial democracy. The National Urban League and our co-conveners of the Demand Diversity Roundtable will resist these threats.

# IRS Announces Jan. 27 Start to 2025 Tax Filing Season; Agency Continues Historic Improvements to Expand, Enhance Tools and Filing Options to Help Taxpayers

Free File program now open; Direct File available starting Jan. 27 for taxpayers in 25 states

WASHINGTON (Jan. 10, 2025)—The Internal Revenue Service today announced that the nation's 2025 tax season will start on Monday, Jan. 27, 2025, and will feature expanded and enhanced tools to help taxpayers as a result of the agency's historic modernization efforts.

The IRS expects more than 140 million individual tax returns for tax year 2024 to be filed ahead of the Tuesday, April 15 federal deadline. More than half of all tax returns are expected to be filed this year with the help of a tax professional, and the IRS urges people to use a trusted tax pro to avoid potential scams and schemes.

The 2025 tax filing season will reflect continued IRS progress to modernize and add new tools and features to help taxpayers. Since last tax season, the improvements include more access to tax account information from text and voice virtual assistants, expanded features on the IRS Individual Online Account, more access to dozens of tax forms through cell phones and tablets and expanded alerts for scams and schemes that threaten taxpay-

The IRS has also expanded features and availability of last year's Direct File program. This year, Direct File will be available starting Jan. 27 to taxpayers in 25 states. In addition, the IRS Free File program opens today. Available only on IRS.gov, IRS Free File Guided Tax Software provides millions of taxpayers nationwide access to free software tools offered by trusted IRS Free File part-

The IRS is also working to continue the success of the 2023 and 2024 tax filing seasons made possible with additional resources. The past two filing seasons saw levels of service at roughly 85% and wait times averaging less than 5 minutes on the main phone lines, as well as significant increases in the number of taxpayers served at Taxpayer Assistance Centers across the country. Based on the IRS' current plan and funding levels, the agency will work to provide similar levels of performance on these key service metrics in the upcoming filing season.

"This has been a historic period of improvement for the IRS, and people will see additional tools and features to help them with filing their taxes this tax season," said IRS Commissioner Danny Werfel. "These taxpayer-focused improvements we've done so far are important, but they are just the beginning of what the IRS needs to do. More can be done with continued investment in the nation's tax system."

The Get Ready page on IRS.gov highlights steps taxpayers can take now to streamline the filing process and the many resources available to interact with the IRS before, during and after filing their federal tax return.

#### Direct File opens Jan. 27 for taxpayers in 25 states

On the first day of the filing season, Direct File will open to eligible taxpayers in 25 states to file their taxes directly with the IRS for free: 12 states that were part of the pilot last year, plus 13 new states where Direct File will be available in 2025. During last year's pilot, Direct File was available in Arizona, California, Florida, Massachusetts, Nevada, New Hampshire, New York, South Dakota, Tennessee, Texas, Washington State and Wyoming. For the 2025 tax filing season, Direct File will also be available in Alaska, Connecticut, Idaho, Illinois, Kansas, Maine, Maryland, New Jersey, New Mexico, North Carolina, Oregon, Pennsylvania and Wisconsin.

Direct File will include new features this year to make filing taxes quicker and easier. Similar to commercial tax software, a data import tool will allow taxpayers to opt-in to automatically import data from their IRS account, including personal information, the taxpayer's IP PIN and some information from the taxpayer's W-2.

This year, Direct File users can try a new chat bot to help guide them through the eligibility checker. Live chat will again be available in English and Spanish, and users can opt into additional authentication and verification, which will allow customer service representatives to provide more infor-

Also, this year, Direct File will cover more tax situations.

During the pilot, Direct File supported taxpayers claiming

# **About When to Claim** Social Security and **Taxation of Benefits**

**Dear Rusty:** I am 65 and currently working full-time. Can I apply for and start receiving my Social Security benefit? I'd expect to have to pay income tax on it if/when I do. Signed: Curious Worker

Dear Curious Worker: If you are working full time, you should likely delay claiming Social Security at this time. At age 65, you haven't yet reached your SS full retirement age (FRA), so you will be subject to Social Security's "annual earnings test" which limits how much you can earn from work while collecting early benefits. The earnings limit for 2025 is \$23,400 and if you earn more than the annual limit, SS will take away \$1 in benefits for every \$2 you are over the limit. If you earn significantly over the limit, you may even be temporarily ineligible to collect SS benefits. FYI, the annual earnings limit goes away when you reach your full retirement age, which for you is 66 years and 10 months, or March 2026

As you obviously already know, a portion of your Social Security may be subject to income tax after you start collecting. The threshold for taxation of SS benefits depends on your IRS filing status—if you file your taxes as a single and your combined income from all sources (including half of the SS benefit you received during the tax year) exceeds \$25,000 then 50% of your received SS benefits are taxable. But if you file taxes as "married/jointly" and your combined income is over \$32,000, then up to 85% of your received SS benefits are taxable. Thus, whenever you claim SS, you may wish to consider having income tax withheld from your SS benefit. This is optional, and you can do this by submitting IRS Form W-4V to your local Social Security office, or you could choose to increase your income tax withholding at work or, alternatively, pay estimated income taxes quarterly.

So, whether you can claim Social Security now depends entirely on how much you will earn from working full time prior to your FRA. If you exceed the annual earnings limit before your FRA, SS will take away some of your benefits or, if you greatly exceed the earnings limit, you may even be temporarily ineligible to get benefits (until you either reach your FRA or earn less). But note, if you decide to claim early and any SS benefits are withheld because you exceeded the earnings limit, you will get credit for that (in the form of a slightly increased benefit) after you reach your full retirement age.

the Earned Income Tax Credit, Child Tax Credit and Credit for Other Dependents. This year, Direct File will also cover taxpayers claiming the:

- Child and Dependent Care Credit
- Premium Tax Credit
- Credit for the Elderly and Disabled • Retirement Savings Contribution Credits

In addition to covering taxpayers claiming the standard deduction and deductions for student loan interest and educator expenses, this year, Direct File will support taxpayers claiming deductions for Health Savings Accounts. The Treasury Department estimates that more than 30 million taxpayers will be eligible to use Direct File across the 25 states.

Direct File is a web-based service that works on mobile phones, laptops, tablets or desktop computers. It guides taxpayers through a series of questions to prepare their federal tax return stepby-step. Last year, thousands of Direct File users got help from IRS customer service representatives through a live chat feature in English and Spanish. Once taxpayers have completed their federal tax return, the Direct File system automatically guides them to state tools to complete their state tax filings.

#### Free File program opens early; available in English and Spanish

Although the IRS will not begin accepting tax returns until Jan. 27, taxpayers have several options available now to get a head start on their taxes.

file electronically for free by using IRS Free File, available only on IRS.gov. Now in its 23rd year, Free File offers free tax preparation software from eight companies in the public-private partnership between the IRS and Free File Inc. As part of this partnership, tax preparation and filing software partners offer their online products to eligible taxpayers for free. To access these free tools, taxpayers must start from the IRS Free File page on IRS.gov.

This year, eight private-sector partners will provide online guided tax software products for taxpayers with an Adjusted Gross Income (AGI) of \$84,000 or less in 2024. Additionally, one partner will offer a product in Spanish.

Although the IRS official tax filing season begins later this month, IRS Free File providers will allow taxpayers to prepare and file returns now and hold them until they can be electronically filed on that date. Many other 2024 filing seasons.

# Other free options to file tax

In addition to Free File and Direct Starting today, almost everyone can File, the IRS reminds taxpayers there are important programs available to help taxpayers:

- Volunteer Income Tax Assistance/Tax Counseling for the Elderly. Taxpayers can find organizations in their community with IRS certified volunteers that provide free tax help for eligible taxpayers including working families, the elderly, the disabled and people who speak limited English.
- MilTax. A Department of Defense program, MilTax generally offers free return preparation and electronic filing software for federal income tax returns and up to three state income tax returns for all military members, and some veterans, with no income limit.

The feature helps to educate taxpayers on common scams and fraudulent efforts to steal taxpayer information and provide taxpayers with more ability to validate the legitimacy of IRS communications.

Redesigned Notices: The IRS successfully redesigned 284 notices in 2024, exceeding the agency's 200 notice goal. It is important to note that 200 notices were redesigned and deployed in 2024 and that the 84 addi-

tional redesigned notices are in line to be deployed in 2025. All notices will be added to Individual Online Account so taxpayers receiving a specific letter can see them.

Forms: Taxpayers can now access 67 forms on cell phones and tablets. The most recent forms feature "save and draft"

Mobile-Adaptive

capabilities, which allow the taxpayer to start a form, save it and return to it later. The addition of save and draft allows for future capabilities, including the ability for multiple spouses

to sign a form.

Virtual assistants to help with refunds, others questions: Whether a taxpayer uses an online tool or calls the IRS, they will experience upgraded help features. During filing season 2025, the IRS will offer voicebot services to all taxpayers calling the IRS for refund information. The voicebot is available in English and Spanish and has helped thousands of callers without the need to wait for the next available representative. Taxpayers will have to authenticate their identity to gain access to their refund information by providing select information from their tax return.

Last year the IRS began using online chatbots for various functions. These chatbots use either

guided help through choice buttons or an open text box for a customized question. The chatbots use natural language processing and understanding to interpret the input from the taxpayer to provide an appropriate response. To launch the chatbot, the taxpayer simply clicks on the "Chat" button in the lower right corner of the webpage. Currently taxpavers can use chatbots from eight webpages.

#### Taxpayers should check 'Where's My Refund?' on IRS.gov

Most refunds are issued in less than 21 calendar days. Taxpayers can use Where's My Refund? to check the status of their 2024 income tax refund within 24 hours of e-filing. Refund information is normally available after four weeks for taxpavers who filed a paper return. Information on Where's My Refund? will update overnight so there is no need to check the tool more than once a day.

The easiest, safest and fastest way to receive a refund is to file electronically (e-file) and select direct deposit. According to Treasury's Bureau of the Fiscal Service, paper refund checks are 16 times more likely to have an issue, like the check being lost, misdirected, stolen or uncashed. People should check FDIC and National Credit Union Administration websites if they don't have a bank account. Veterans can use the Veterans Benefits Banking Program to find participating financial institutions.

The IRS also notes that starting Jan. 1, 2025, people will no longer be able to buy paper Series I savings bonds with their tax refund. Instead, Series I bonds are available in electronic format in TreasuryDirect.

#### Choose a trusted tax professional

More than half of taxpayers turn to a tax professional for help filing a tax return. While most tax preparers deliver exceptional and professional service, selecting the wrong preparer can lead to financial harm.

Taxpayers should review the tips for choosing a tax preparer and learn how to avoid unethical "ghost" return preparers. Taxpayers can also use the IRS Directory of Federal Tax Return Preparers with Credentials and Select Qualifications to find trusted professionals. The IRS also reminds taxpayers that choosing someone affiliated with a recognized national tax association is always a good option.

Tax professionals accepted into the IRS electronic filing program are authorized IRS e-file providers, qualified to prepare. transmit and process electronically filed tax returns.
