PRINCE GEORGE'S COUNTY Board of License Commisioners

R.R. NO 36 – ENTERTAINMENT PERMIT APPLICATION PROCESS:

As directed under Section 26-1103 of the Alcoholic Beverages Article of the Annotated Code of Maryland, the Board of License Commissioners is authorized to issue a Special Entertainment Permit and Family Entertainment Permit to qualified businesses with Class B Licenses. Refer to R.R. 75 for the types of entertainment.

<u>Note</u>: Special or Family Entertainment Permits are not transferrable. Entertainment Permits may be applied for in conjunction with the submission of a new or transfer application.

At the time of issuance of a new license, the transfer or renewal of a license, or during the license year, the Board shall have the power and authority to prohibit, condition, or restrict the type of entertainment offered on the license premises.

The <u>Family Entertainment Permit</u> authorizes the holder to provide entertainment and impose a cover charge when the business offers entertainment directed at and suitable to families under conditions as determined by the Board and in compliance with all County laws. The seating capacity of the room with entertainment shall not exceed 110. The average daily receipts from the sale of food will be at least 60% of the total daily receipts. The full menu without price deviation shall always be available. Refer to Section L for the hours of operation.

The Annual Permit Fee is \$250.

The <u>Special Entertainment Permit</u> authorizes the holder to provide entertainment, allow patron dancing, with the appropriate County permit, and impose a cover charge under conditions as determined by the Board and in compliance with all County laws. Refer to Section K for the hours of operation.

The Annual Permit Fee is \$1,500.

- A. Application Process for the Special Entertainment Permit or a Family Entertainment Permit:
 - The initial request for a Special Entertainment Permit, Family Entertainment Permit or modification to a previously issued permit shall include:
 - A security plan, secondary employment business agreement, and a copy of the application submitted to the Prince George's County Police Department (PGPD).
 - b. A security plan is required to prevent the premises from causing a threat to the peace and safety of the surrounding area. The applicant may utilize sworn security personnel as part of the plan if the sworn security personnel has police powers in the jurisdiction where the premises is located.
 - c. The security plan must be reviewed and approved by the PGPD prior to submission of the application to the BOLC.
 - d. The PGPD will conduct a site inspection, and upon approval, will send a security plan approval letter to the applicant and the BOLC.
 - e. It is the licensee's responsibility to provide a copy of the security plan to the Police Department for the municipality.
 - 2. A fully completed Entertainment Permit Application must be submitted to the BOLC thirty (30) days prior to the next available hearing along with the following:
 - a. Application fee of \$250.
 - b. Use & Occupancy Permit with entertainment endorsement.
 - c. Fire Capacity Certificate required for establishments with 50 or more seats. Establishments with a seating capacity of less than 50 must provide confirmation from the Prince George's County Fire/EMS Department that a Fire Capacity Certificate is not required. (Also not required for renewal)
 - 3. A hearing will not be scheduled until the requirements of Section A and B above are both met.
 - 4. Prior to scheduling a hearing, the BOLC will advertise and post signs that the establishment is applying for an entertainment permit.
 - 5. BOLC administrative staff will conduct tax checks to ensure that there are no outstanding balances.
 - 6. During the public hearing, the Board will consider the type of entertainment, the days, and hours of the entertainment when determining whether to issue a Special Entertainment Permit or Family Entertainment Permit. The Board is authorized to prohibit, condition, or restrict the type of entertainment provided on the licensed premises.
 - 7. The Board will review any comments on the security plan from the PGPD
 - a. The PGPD is responsible for providing the Board with any comments on the security plan within 30 days of the PGPD's receipt of the plan from the applicant.
 - b. For each security plan in which the PGPD provides comments, a representative from the PGPD will be requested to attend the public hearing and present the PGPD's comments and position on the security plan and answer questions the applicant or the Board has regarding the comments of the PGPD. If a PGPD representative does not attend the hearing, he/she shall submit a report to the Board stating the PGPD's position.
 - 8. The Board shall prohibit, condition, or restrict any class of license after a hearing when a determination is made that the type of business and entertainment conducted under the license adversely impacts or unduly disturbs the community as a public nuisance and is not harmonious to the peace, health, welfare, and safety of the residents of Prince George's County.

If applicable, the fee for a new entertainment permit may be prorated based on the date all required documents are received by the BOLC.

- 9. Pursuant to Section 3-604 of the Alcoholic Beverages Article of the Annotated Code of Maryland, Adult Entertainment is restricted except in the case of:
- An establishment that is a theater, concert hall, or museum that is primarily devoted to the arts or theatrical performances.
- 10. Performances that express matters of serious literary, artistic, scientific, or political value. This authority shall include but not be limited to restricting the entertainment known as lewd, exotic, or go-go dancing, topless, bottomless, striptease, loud and raucous entertainment.
- 11. After the issuance of the Special Entertainment Permit, licensees are required to adhere to the following:
 - a. The hours of 9:00 p.m. and 2:00 a.m. the next day, prohibit individuals under 21 years of age from being on the part of the premises where the entertainment is occurring (exception: employees and immediate family members of the permit holder) when the privileges of the Special Entertainment Permit are being exercised.
 - b. Individuals under 21 who are already on the part of the licensed premises where the entertainment is occurring (or will occur) should be informed prior to 9:00 p.m. (or the time that the entertainment begins) that they shall leave that part of the licensed premises by 9:00 p.m.
 - c. Once issued, a Special Entertainment Permit shall be valid until November 30th of the following permit year unless otherwise specified or it is suspended or revoked by action of the Board.
 - d. Any change in entertainment must be approved by the Board pursuant to a hearing. When applying to change entertainment, the licensee shall also include evidence that an amended security

plan has been submitted to the Prince George's County Chief of Police (and to the local police department if the licensed premises is in any municipality).

<u>Note</u>: Unless otherwise stated on the Use & Occupancy Permit or restricted by the Board, the hours of operation for the Special Entertainment Permit are the following:

Sunday – Thursday Friday – Saturday Saturday – Sunday 9:00 p.m. to 2:00 a.m. 9:00 p.m. to 3:00 a.m.

- 12. After issuance of the Family Entertainment Permit, licensees must adhere to the following:
 - a. End entertainment by 12 midnight.
 - b. Once issued, a Family Entertainment Permit shall be valid until November 30th of the following permit year unless otherwise specified or it is suspended or revoked by action of the Board.
 - c. Any change in entertainment must be approved by the Board pursuant to a hearing. When applying to change entertainment, the licensee shall also include evidence that an amended security plan has been submitted to the Prince George's County Chief of Police (and to the local police department if the licensed premises is in any municipality).
- B. Entertainment Permit Renewal Process:
 - 1. Renewal of the Special Entertainment Permit or Family Entertainment Permit shall include an application to be filed between August 15th and September 15th of each year to ensure that the licensee may continue to offer entertainment while the application is being processed.
 - Entertainment renewals will follow the same process as a new application. Documents required for submission can be found above in Section A. However, a hearing is not required for renewal applications.
 - a. The annual renewal fee for a Special Entertainment Permit is \$1,500
 - b. The annual renewal fee for a Family Entertainment Permit is \$250
 - c. Entertainment Permit renewal fees are not prorated.
- C. Special Entertainment Permit holders may downgrade at any time during the cycle; however, Family Entertainment holders that wish to upgrade to Special Entertainment Permits must appear before the Board. In this instance, the Security plan must be updated and approved by the police department.

The process of downgrading from a Special Entertainment Permit to a Family Entertainment Permit must be completed during renewal, see Section B. Those that upgrade from a Family Entertainment Permit to a Special Entertainment Permit will be required to pay the \$1,500 annual fee. If applicable, the fee for a new entertainment permit may be prorated based on the date the permit is put into use. A \$250 application fee applies to the upgrade of the permit.

- D. Licensed establishments that are specifically exempt by statute from having an Entertainment Permit are authorized to have entertainment without an Entertainment Permit. In addition, if entertainment is specifically provided to a licensed establishment by statute, an Entertainment Permit is not required for the entertainment that the statute authorizes.
- E. This rule does not prohibit entertainment between 2:00 a.m. and 3:00 a.m. for licensed establishments that qualify to be open during that time on Saturday and Sunday mornings.
- F. Fine/Suspension/Revocation of the Entertainment Permit:

The Board may immediately suspend an Entertainment Permit if the Board determines pursuant to majority vote that the licensee failed to follow its security plan or deviated from the representations made to the Board regarding the provision of entertainment on the licensed premises. If the Board suspends the Entertainment Permit, it shall hold a hearing regarding the status of the Entertainment Permit within 30 days. The Board will determine at the hearing whether it shall fine the licensee, continue the suspension of the Entertainment Permit, revoke the Entertainment Permit, reinstate the Entertainment Permit, and/or take any other appropriate actions.

- 1. If the Entertainment Permit is revoked by the Board, the establishment will not be eligible for an Entertainment for a period of not less than
- 2. The Board may immediately suspend the Entertainment Permit if the Board reasonably believes that the holder of the permit is not in compliance with county zoning, property standard or use and occupancy requirements.
- A licensee may not deviate from the entertainment, days, times, and other conditions without Board permission. A significant deviation without prior Board approval constitutes grounds for the Board to immediately suspend the permit.
- 4. If the establishment has an Entertainment Permit but is authorized by the Board to host on the licensed premises weddings or corpo rate receptions, reunions, anniversary celebrations, retirement or birthday parties, confirmation ceremonies, or other types of events that are family oriented and have entertainment, individuals under 21 years of age may remain on the part of the premises where the entertainment for the family oriented event is occurring between 9:00 p.m. and 2:00 a.m., pursuant to the Board's prior authorization.
- 5. Licensed establishments that are specifically exempt by statute from having an Entertainment Permit are authorized to have entertainment without an Entertainment Permit. In addition, if entertainment is specifically provided to a licensed establishment by statute, an Entertainment Permit is not required for the entertainment that the statute authorizes.
- 6. This rule does not prohibit entertainment between 2:00 a.m. and 3:00 a.m. for licensed establishments that qualify to be open during that time on Saturday and Sunday mornings.
