## NOTICE OF PUBLIC TAX SALE OF REAL ESTATE IN PRINCE GEORGE'S COUNTY, MARYLAND

### INTERNET-BASED TAX SALE MONDAY, MAY 11, 2026

**A Tax Sale does not immediately transfer ownership to the purchaser. Legal procedures must be completed before ownership is conveyed. The current owner retains ownership and may redeem the property by paying the taxes owed until a deed is issued to the tax sale purchaser.**

Notice is hereby given that the following is a list of amounts due and in arrears to Prince George's County, Maryland, municipal corporations within the County, and the State of Maryland. Properties are listed alphabetically by the owner's last name, as reflected on the County tax rolls at the time of publication.

Notice is hereby further given that, if these amounts, including all applicable interest, penalties, and costs are not paid by 4:00 p.m., Friday, May 8, 2026, by the current property owner(s), the undersigned will offer the properties listed below for sale through an Internet-based auction for the properties listed below. **Payment must be made by cashier's check, money order or credit card; PERSONAL CHECKS WILL NOT BE ACCEPTED.** Bids will be received in accordance with the instructions listed below.

This notice and list of delinquent properties are published in accordance with the laws of the State of Maryland and Prince George's County, Maryland. The Director of Finance publishes this notice in *The Enquirer Gazette* and *The Prince George's Post* to inform property owners of properties subject to tax sale for delinquent taxes. The listing is also available online at <https://taxsale.princegeorgescountymd.gov>.

Owners may prevent the sale by paying the amounts due at the Treasury Office, 1301 McCormick Dr., Suite 1100, Largo, MD 20774, no later than 4:00 p.m., Friday, May 8, 2026. Payments may also be placed in the payment slot by the building entrance. Cash is NOT accepted. After this date, additional charges will apply to redeem the property.

During the advertising period, April 10 through May 8, properties will be removed from the list as payments are received. As a result, the final newspaper advertisement on May 8 will reflect fewer properties than were originally listed. The property listing on the County's website will be updated weekly, with the final update occurring after 4:00 p.m. on May 8, 2026. The website will indicate when the final update has been completed.

The tax sale is open to the public. **Prospective bidders should investigate properties prior to bidding.** There is no warranty, expressed or implied, regarding title, property boundaries, condition, or market value, or that the property is free from defects that may affect tax sale foreclosure. The purchaser assumes all risks relating to the property, including its condition, title, location, and marketability. All properties are sold "AS IS". Purchasers will receive a certificate of sale as required by law.

If a tax sale of a property is later invalidated by the Collector, the purchaser will receive a refund of the amount paid at tax sale. NO redemption interest or reimbursement of attorney fees, title search costs, or other expenses will be provided.

The County will offer tax lien certificates on individual properties through an Internet-based, sealed direct-bid auction using the high-bid premium method, as authorized by § 14-817 of the Annotated Code of Maryland, Tax-Property Article. This is NOT a live auction. No property will be sold for less than the advertised amount due.

No later than the day following the tax sale, the successful bidder must pay the full advertised amount, plus any applicable high-bid premium.

#### All tax sale bidders must complete the following steps prior to being permitted to bid:

- Register online at: <https://taxsale.princegeorgescountymd.gov>.** Mail-in or email registrations **will not be accepted.** Registration opens April 10, 2026, and closes April 24, 2026, at 5 p.m. EST. All registration requirements must be completed by the deadline.
- Pay a \$150.00 non-refundable registration fee and a \$1,000.00 deposit** via ACH debit. The registration fee will not be applied to any certificate purchase. The deposit will be applied to certificates, and any unused balance will be refunded. Payment must be made in U.S. Dollars.
- Provide valid bank routing and account information** for ACH debit of the registration fee and deposit.
- Accept all terms and conditions** in the "Tax Sale Information and Procedures" and the "Bidding Rules".

All bids shall be submitted through the tax sale website. Bidding will open on May 4, 2026. Certificates will be awarded to the highest bidder on May 11, 2026, based on batch groupings posted on the website.

Batches are subgroups of the advertised properties used to organize bidding. Each tax certificate within a batch is offered independently, and each batch has a designated closing time. Each account residency code will be marked as **RES** for principal residence and **NON** for non-principal residence/ unimproved lots.

Certificates will be grouped into three batches.

- Batch 1:** Closes at 10:00 a.m. EST
- Batch 2:** Closes at 12:00 p.m. EST
- Batch 3 (Unimproved Properties):** Closes at 2:00 p.m. EST

Bids will be accepted until the designated closing time and awarded to the highest bidder.

Bids may be submitted as a dollar amount or as a bid factor (a percentage of the property's assessed value). For example, a bid factor of 0.46 represents 46% of the property's assessed value.

All bids must be made in good faith and are final. Bidders are responsible for all bids placed, whether intentional or not, and bids may not be withdrawn. The successful bidder is responsible for full payment of each awarded certificate, including any applicable high-bid premium. Failure to remit full payment will result in forfeiture of all awarded certificates, may disqualify the bidder from future tax sales, and forfeited certificates may be awarded to the next highest bidder.

**Each successful bidder will receive an invoice via email by 4:00 p.m. EST on the day of the tax sale. Payment must be made in guaranteed funds, either by wire transfer or cashier's check, for the total amount due for awarded certificates, including any associated high-bid premium.**

**Cashier's checks must be delivered to the Prince George's County Office of Finance, Treasury Office, 1301 McCormick Drive, Suite 1100, Largo, Maryland, by 3:00 p.m. EST on the day following the tax sale. Wire transfers must be sent in accordance with the instructions provided on the invoice and received in the County's bank account by 3:00 p.m. EST the day following the tax sale.**

Pursuant to § 14-817(b) of the Tax-Property Article, the County has established a high-bid premium for certificates sold through the sealed bid process. This high-bid premium is 20% of the amount by which the bid exceeds 40% of the property's assessed value. The high-bid premium is due and payable at the time of payment for the tax lien.

The County will refund the high-bid premium, without interest, to the certificate holder upon redemption of the property, or to the plaintiff upon issuance of a tax sale deed following a successful foreclosure action. The high-bid premium is not refundable if the property is not redeemed and an action to foreclose the right of redemption is not filed within the time required under § 14-833 of the Tax-Property Article. It is also not refundable if a foreclosure action is filed and subsequently dismissed without redemption.

Upon redemption, the certificate holder of the plaintiff may be reimbursed for attorney's fees and expenses incurred in connection with a foreclosure action, as provided in §14-843 of the Tax-Property Article. **Purchasers must notify the Treasurer's office via email of the party handling the release once such fees are incurred.**

Pursuant to § 14-843(b)(1) of the Tax-Property Article, the plaintiff or certificate holder "is not entitled to be reimbursed for expenses incurred within seven months after the date of sale" unless an expedited foreclosure suit has been authorized in accordance with § 14-843(b)(2)(i) and Section 14-833(e) of the Tax-Property Article.

Attorney's fees and expenses may be added after four months only for non-owner-occupied properties or vacant lots, and seven months on principal residence accounts, as permitted by law.

Upon request by the County or the redeeming party, the purchaser must provide an itemized statement of charges in accordance with the preceding provisions. If no response is received within five (5) days, the property may be redeemed without payment of legal fees.

Successful bidders must complete and upload an IRS Form W-9 (Request for Taxpayer Identification Number and Certification) and an Authorization for Electronic Funds Disbursement (ACH). Redemption payments will be issued via ACH. Please note that electing to receive payment by paper check will result in additional processing time.

The Collector will provide tax sale purchasers with IRS form 1099-INT, as required by law.

#### The tax sale purchaser and his/her attorney must comply with the following requirements:

- Provide a staffed telephone number** to the Treasurer's Office (a number answered during business hours; voicemail-only lines are not acceptable).
- Provide a valid email address** for correspondence.
- Provide an itemized statement of legal fees and expenses** to the redeeming party within two (2) business days of the request.
  - The purchaser and his/her attorney must also provide a written release immediately upon receipt of all fees and expenses.
  - A copy of the release must be sent immediately to the Treasurer's office via email at [taxsale@cg.pg.md.us](mailto:taxsale@cg.pg.md.us) or by fax at 301-952-4261.

Failure to comply with these requirements may result in the purchaser being barred from future sales and denial of reimbursement for legal fees.

In the unlikely event that technical issues cause the tax sale website to become unavailable before the auction is completed, all registered bidders will be notified when the site is restored and the auction resumes. Notification will be provided via email, voice message, or telephone using the contact information supplied during registration.
