## Brown Delivers Address on the Future of Maryland

Build on Progress by Investing in Businesses, Schools, Health Care, Infrastructure Emphasizes

OCEAN CITY, Md. (August, 2012) – Lt. Governor Anthony G. Brown delivered the keynote address at the Maryland Association of Counties (MACo) Summer The Lt. Conference. Governor's remarks focused on the keys to building a bright economic future and creating jobs in Maryland: continued investment in our schools, making health care affordable and accessible for all Marylanders, modernizing our infrastructure, and encouraging private sector growth by supporting Maryland businesses.

"Today I want to talk to you about the future that I see for Maryland," said Lt. Governor Brown. "It's easy to just see our economy as numbers that go up and down with each passing month - a percentage point here and there. We must focus on building a bright economic future for the people behind the numbers, for the Marylanders who are working hard to suc-

The Lt. Governor continued, "Because the American Dream starts with a job, we must focus our efforts on getting Marylanders back to work. Building quality schools, expanding access to health care, and modernizing infrastructure are all essential for job creation. We also need to help our private sector grow, which means helping businesses directly so they can create iobs."

"Under Governor O'Malley's leadership, we've built the country's best school system, reduced our crime rate to historic lows, maintained a Triple A bond rating, and balanced our budget through six difficult years of recession and recovery," said Brown. "Maryland is a great State, but I know that we can build on our success and make it better."

"The greatest challenge of our time, for us as leaders and as a State, particularly as we recover from this recession, is to address the persistent gaps and disparities that exist in our communities. I believe that in counties throughout Maryland, each of us is strengthened when all of us succeed, and we all suffer when members of our communities don't reach their full potential. I know that meeting these challenges will be difficult, but I also know each of us has been entrusted by the people to make the difficult choices and to ensure a bright future," said Brown.

## **School Bus Cameras Will Nab Drivers Failing to Stop for School Buses**

Thousands Of Motorists In Md. Illegally Pass School Buses Each School Day

(August, 2012) – It happens 72,000 times each school day across the country, and it also occurs more than 7,000 times daily on roadways in Maryland during the school year. As the new school year dawns, Montgomery County will crack down on motorists who flagrantly zip pass a stopped school bus while it is loading and unloading students. To combat the problem, the Montgomery County Public Schools has outfitted a number of its school buses with automated school bus safety cameras. So adjust your driving habits accordingly.

Lights, Camera, Stop! If you illegally pass a stopped school bus come Monday, August 27, the County Police will use the video evidence captured by the bus's newly installed stop-arm camera to issue traffic citations, warns AAA Mid-Atlantic. The hefty fine will set you back a pretty \$250. It is the latest weapon in the growing arsenal of automated traffic enforcement cameras deployed across

## **Obama Administration Announces New** Design, Expanded Content for Recreation.Gov

Features Make it Easier to Discover and Explore Parks, Recreation Areas and, Public Lands

WASHINGTON -- As part of President Obama's initiative to fuel the economy and create jobs by promoting travel and tourism, the administration today announced a new design, improved navigation tools and expanded content Recreation.Gov, the interagency website that guides visitors to 90,000 sites on federal lands such as national parks, wildlife refuges, waterways, forests and recreation areas.

The redesign of www.recreation.gov is an initial step in a multi-year strategy to engage visitors with enhanced interactive content and more multimedia, mobile, trip-planning tools. The seven million visitors who use the web site every year will be able to make reservations, see ready-made itineraries for destination cities, and search

#### MedStar offers big plans for Southern Maryland Hospital MedStar has acquired our

local hospital, making it one of ten owned by MedStar, a noncommunity-based healthcare organization serving the Baltimore/ Washington region. Included among the ten are Georgetown and Washington Hospital Center. The merger should be complete by the end of the year.

Michael Chiaramonte, CEO of Southern Maryland Hospital Center, spoke to a hundred or so community leaders at the Colony South Hotel on August 14. I went, representing the Skyline Citizens Association.

He talked about his father, Dr. Francis P. Chiaramonte, a urologist with offices in Marlow Heights, who founded the hospital in 1977 because he believed Southern Maryland needed a hospital. Chiaramonte handed it over to his son several years ago. Michael Chiaramonte talked about how family-owned hospitals are increasingly rare, due to growing health demands.

They invited bids and 15 health systems responded. The number one criteria, Chiaramonte said, was "what will you pledge to do and MedStar offered when?" \$150 million and plans for an oncology program; neurosciences center for stroke care; spine, back and clinical trials; and more. New buildings and parking garages will go up on the property.

Chiaramonte will stay on for at least three years, as president. He also said they will not sell Colony South.



## Statement from Prince George's County Executive Rushern L. Baker On Prince George's Police Department Tragic Vehicle Crash Incident

"Today is a very sad day for the Prince George's County government and our public safety community. The other officer was seriously injured and is expected to survive. Like so many other officers, these men did not think about the risks in this particular situation because they were just doing their jobs. #### **Cardin Rebukes Appeals Court Decision** on Cross-State Air Pollution

"Air pollution doesn't stop at the state bor-

Washington, DC – U.S. Senator Ben Cardin (D-MD), a member of the Senate Environment and Public Works Committee, responded with the following remarks to the federal appeals court decision that struck down the EPA's ability to protect states from air pollution that crosses state lines.

"It doesn't take a scientist to understand that air pollution doesn't stop at a state borderline. Despite today's court decision, the need to address cross-state air pollution remains as urgent as ever. Maryland, despite having some of the strictest clean air rules in the country, continues to suffer from dirty air - and the resulting harm to public health – because of pollution from other states. More than half of the smog in Maryland originates outside of our the state. Federal efforts are essential to protecting our communities from the damaging effects of air pollution."

#### Statement from MDE Secretary on Court **Ruling on Federal Air Quality Rule**

BALTIMORE, MD (August 21, 2012) -Maryland Secretary of the Environment Robert M. Summers today released the following statement on the ruling by the U.S. Court of Appeals for the District of Columbia vacating the U.S. Environmental Protection Agency's Cross-State Air Pollution Rule (CSAPR), which addresses air pollution from power plants that contributes to unhealthy air in downwind states. "The court ruling vacating EPA's CSAPR rule is very disappointing. Maryland was among a group of states that intervened in the court case to defend the rule. The court decision deals a significant blow to our ongoing efforts to improve the quality of our air in Maryland. Maryland has worked very hard to reduce air pollution through programs such as the Maryland Healthy Air Act, the toughest power plant emission law on the east coast, and the Clean Cars Program and through implementation of stringent emission limitations on many other sources. Because as much as 70 percent of our air pollution problem comes from upwind states, we need the emis-

sions reductions from sources in these states that we would have realized from implementation of CSAPR.

"The 2005 Clean Air Act Interstate Rule remains in effect, but that rule is not strong enough to protect Marylanders from the effects of out-of-state air pollution. We are reviewing the court's 100-plus-page decision and will confer with EPA on any next steps. In the meantime, we continue to do as much as we can in Maryland to protect our environment and the health of our citizens."

#### Mikulski Statement on Deadly CSX Train **Derailment in Ellicott City**

WASHINGTON – U.S. Senator Barbara A. Mikulski (D-Md.) today issued the following statement following the tragic CSX freight train derailment in Ellicott City: "My thoughts and prayers go out to the families of those lost as a result of this tragic derailment. My gratitude goes out to the first responders who have worked tirelessly to protect Ellicott City residents following this disaster.

"It's concerning that this is the third safety incident in Maryland involving a CSX train this month, and the second partial derailment in Howard County. I urge the NTSB to conduct its investigation thoroughly and quickly to ensure the safety of Maryland communities and provide answers for the families grieving today. CSX must get to the bottom of what went wrong and outline what steps they are taking to ensure it will never happen again.

## People with Medicare Save Over \$4.1 Billion on Prescription Drugs Thanks to the Health Care Law

Seniors and People with Disabilities in Maryland Have Saved \$59.7 Million Since 2010

As a result of the Affordable Care Act – the health care law enacted in 2010 - seniors and people with disabilities in Maryland have saved \$59.7 million on prescription drugs since the law was enacted, Health and Human Services (HHS) Secretary Kathleen Sebelius announced today. Seniors in Maryland saved an average of \$662 in the Medicare prescription drug coverage gap known as the "donut hole" in 2012. Nationwide, nearly 5.4 million seniors and people with disabilities have saved over \$4.1 billion on prescription drugs.

In addition, during the first seven months of 2012, the new health care law has helped 535,470 people with original Medicare in Maryland get at least one preventive service at no cost to them.

"The health care law has saved people with Medicare over \$4.1 billion on prescription drugs, and given millions access to cancer screenings, mammograms and other preventive services for free," said

Secretary Sebelius. "Medicare is stronger thanks to the health care law, saving people money and offering new benefits at no cost to seniors."

benefits to make Medicare prescription drug coverage more affordable. In 2010, anyone with Medicare who hit the prescription drug donut hole received a \$250 rebate. In 2011, people with Medicare who hit the donut hole began receiving a 50% discount on covered brand-name drugs and a discount on generic drugs. These discounts and Medicare coverage gradually increase until 2020 when the donut hole is closed.

The health care law also makes it easier for people with Medicare to stay healthy. Prior to 2011, people with Medicare had to pay extra for many preventive health services. These costs made it difficult for people to get the health care they needed. For example, before the health care law passed, a person with Medicare could pay as much as \$160 for a colorectal cancer screening. Thanks to the Affordable Care Act, many preventive services

are offered free of charge to beneficiaries, with deductible or co-pay, so that cost is no longer a barrier for seniors who want to stay The health care law includes healthy and treat problems early.

In 2012 alone, 535,470 with traditional Medicare in Maryland - or 76% of those eligible – have received at least one preventive service at no cost to them. This includes 43,690 who have taken advantage of the Annual Wellness Visit provided by Affordable Care Act.


In 2011, an estimated 32.5 million people nationwide with traditional Medicare Medicare Advantage received one or more preventive benefits free of charge.



## Cardin, Lugar, Leahy and Welcome **SEC Approval of Transparency Rules**

Washington, DC - U.S. Senators Ben Cardin (D-MD), Dick Lugar (R-IN), and Patrick Leahy (D-VT) welcomed action by the Securities and Exchange Commission (SEC) to implement the "Cardin-Lugar Amendment" on extractives industry transparency.

"I'm pleased that the SEC has adopted the long-overdue final rule implementing the Cardin-Lugar Amendment. Increased transparency reduces the risk for U.S. investors and allows citizens in resource-rich countries to hold their leaders accountable. Finally, the U.S. has the tools in place to add accountability and stability to the inherently unstable energy sector. It's now up to the extractive industries and regulators to make sure enforcement of the regulations complies with the intent of Congress," said Senator Cardin. "Increased transparency will not put companies that comply at a competitive disadvantage. We also expect, with U.S. leadership, the SEC rule will become the norm for governments and markets around the world."

"Information is power. It is power for shareholders and power for citizens living under oppressive regimes. With the Cardin-Lugar Amendment, the U.S. is leading the world in the moral and economic necessity to choose transparency over shadow, rule of law over corruption. Now that U.S. law will be implemented, we call on our European colleagues to join us," Senator Lugar said. "We will carefully examine the rule approved today that it conforms with the plain language of the law."

"Sunshine is a powerful disinfectant, and the SEC has just pulled back some curtains. I hope that the SEC's final rule relating to Section 1504 will increase transparency for companies involved in the development of oil, natural gas

and minerals," added Senator Patrick Leahy, Chairman of the Senate Judiciary Committee who as a conferee worked closely with Senators Cardin and Lugar when he successfully offered the amendment during the Dodd-Frank conference negotiations that created Section 1504. "This will help make governments in resourcerich countries more accountable to their people. It is too soon to tell whether this is a perfect rule, but it is long past the time for indecision and inaction. I commend the SEC for taking action to increase corporate responsibility, promote energy security and provide U.S. investors with the information they need to properly analyze these

Earlier this month, Lugar and Cardin renewed their call for prompt SEC action to implement the Cardin-Lugar Amendment. http://www.huffingtonpost.com/sen-dick-lugar/senate-to-sec-acton-card\_b\_1729306.html

The Cardin-Lugar Amendment became law in 2010 as Section 1504 of the Dodd-Frank Act and required the SEC to promulgate rules for implementation. The Cardin-Lugar Amendment requires transparent reporting of payments made to governments for the extraction of oil, natural gas, and minerals by companies that otherwise must file disclosures with the SEC. Once fully implemented, the Cardin-Lugar Amendment will help empower investors to have a more complete view of the value of their holdings and encourage capital formation. It will bring more information to global commodities markets, which would benefit price stability. And it will help empower citizens to hold their governments to account for the decisions made by their governments in the management of valuable oil, gas, and minerals resources and revenues.

## Eric Holder, Bernette Johnson Honored at Whitney M. Young Awards Gala

Two recipients of National Urban League awards at our recent annual conference in New Orleans are emblematic of our "Occupy the Vote" campaign to protect the voting rights of millions of Americans this November. Attorney General Eric Holder has likened the sudden proliferation of voter ID laws to modern day "poll taxes," and has made stopping voter suppression one of the Justice Department's top priorities. And Louisiana's first African American woman Supreme Court Justice, Bernette Joshua Johnson, who is the second longest serving judge on the Court and thus in line to be the next Chief Justice this February, is currently facing an unconstitutional effort to deny her that seat – a clear violation of the Voting Rights Act.


I was proud to present a Living Legend award to A.G. Holder and the President's Award to Justice Johnson at our Whitney M. Young awards gala on July 28th.

Since Eric Holder's 2009 appointment by President Obama as the first African American Attorney General in American history, he has reclaimed the nation's commitment to fairness, and expanded opportunity. Over the past three years, his Civil Rights Division has filed more criminal civil rights cases than ever before; and he has made significant strides in combatting discrimination in the nation's housing and lending markets. His commitment to voting rights is especially noteworthy.

In response to the outbreak of voter ID and restriction laws across the country, Attorney General Holder has initiated thorough reviews of proposed voting changes "in order to guard against disenfranchisement, and to help ensure that none of these proposals would have a discriminatory purpose or effect." Last December, his Justice Department rejected South Carolina's new voter ID law, finding that it discriminated against minority voters. And in June, the Federal District Court in Miami granted an injunction blocking Florida's new and "onerous" restrictive voter registration law. The Justice Department also found that Florida's effort to purge its voter rolls of suspected non-citizens may violate Section 5 of the Voting Rights Act.

Justice Bernette Johnson was first elected to serve on the Louisiana Supreme Court in 1994 and is currently the second longest serving Associate Justice on the Court. Highly respected for her legal acumen and fairness, she has received numerous awards, including the 2009 Distinguished Jurist Award presented by the Louisiana Bar Association and the 2000 Medal of Honor which I was honored to present to her during my last term as Mayor of the City of New Orleans.

For much of her life, Justice Johnson has worked as an advocate for social justice and civil rights. Her election to the Louisiana Supreme Court in 1994 made her only the third African American jurist ever to serve on the state's highest court, after the Supreme Court ruled in 1991 that the state's method of electing Supreme Court Justices ensured that black voters would never be able to elect a black justice. The current move to deny her the Chief Justice seat is clearly in violation of the law.

## Mapping the War on the Right to Vote

Our nation's democracy is in a crisis. We are facing the biggest challenge to our nation since its inception. No, there is not an armed rebellion going on, but, oh, is there a war—a silent, insidious, invidious, nefarious, absolutely downright ugly war. And the war is on the right to vote for American citizens.

At the Children's Defense Fund's recent national conference Barbara Arnwine, the Executive Director of the Lawyers' Committee for Civil Rights Under Law and a leader of Election Protection, the nation's largest nonpartisan voter protection coalition, issued an urgent call to action. Right now assaults on voting rights across the country in advance of the 2012 elections are keeping her very busy.

Arwine said 25 million Americans who had voted in 2008 did not vote in the 2010 midterm elections, and when new state legislators came into power after those elections, their first priority was figuring out how to keep those 25 million people from returning to the polls. Legislators in 35 states quickly drafted bills making it harder for people to vote: "everything from photo ID laws, to laws restricting early voting, to laws making it harder for third party registration groups to register people to vote, to laws making it harder for people to vote on Sundays because in many states that's when Latinos and African Americans voted the heaviest, to laws restricting student voting." Arnwine said the lawmakers behind these bills were counting on the targeted voters not noticing what was happening until it was too late.

But, she said, "they forgot that we stand on the shoulders of giants who we will never let down . . . we get up in the morning and we say that we cannot negate the legacy of Fannie Lou Hamer; that we will never forget the legacy of Cesar Chavez; that we never will negate the legacy of Mr. Korematsu; that we never can sit back and let rights be stolen." Arnwine then shared her Map of Shame: Voter Suppression Legislation by State, that shows all of us who are ready to fight back exactly where the battlegrounds are.

The map's original title was the Map of Voter Suppression in the United States, but one day as Arnwine was studying an early version she heard her late father's voice in her head saying what he always did when he saw something wrong: "That's a sin and a shame." It's a sin and a shame that in 2012 we are still fighting the same battles for voting rights that have been going on since the nation was founded and facing some of the same Jim Crow-era voter suppression tactics we hoped were dead and buried after the Civil Rights Movement. But as Frederick Douglass taught us, "Power concedes nothing without a demand. It never did and it never will." So the first step for every one of us is to become familiar with the Map of Shame, especially the current and proposed voting laws in our own states.

Then we each need a plan. Arnwine and her colleagues are doing their part by suing states whose proposed laws violate the Voting Rights Act. But Arnwine stressed that every person can do something to fight in this war on the right to vote, and we each need to decide now how we will execute our roles. Begin by using traditional networks and social networks to make sure every single person you know is a "V.I.P.": they have verified their voter registration status; they have the right identification for their state; and they know their precinct.

The last is important, Arnwine said, "because the biggest devilment that goes on in these elections are what we call deceptive practices-people are going to get robocalls, and they're going to get fliers that claim they're from the NAACP and everything, telling people to go to the wrong polling place . . . if they're in the wrong polling places, in

most states their vote will not count." Securing "V.I.P." status is critical to making sure people will not be disenfranchised on Election Day.

Next, Arnwine said, we need to counter the organized groups who are already planning to send "poll watchers" to African American, Latino, and student voting places to intimidate and harass voters, and we need to "get [our] friends to become poll workers, official poll workers, because that's what they're doing-they're putting them inside of the polling places also, so they can challenge people on the inside and nobody will know what they're doing. So we need good people sitting next to them, making sure that people have access to the ballot." Now is the time to sign up for these roles.

We can also volunteer at Election Protection Coalition Command Centers to help watch out for local problems. Finally, on Election Day every one of us must do the basic job of helping other people get to the polls—as Arnwine says even "if you're bedridden get up in the morning and call everybody you know: 'Are you going to vote today?"

Arnwine summed up this way: "There is a role for everybody. Don't forget. If you forget everything that I said today, if you remember nothing, just remember this one thing: that we can only win this fight if you fight." We cannot stand by and let the right to vote be taken away again on our watch Every one of us must decide what we can do in the fight to protect voting rights today. There's no time to waste.

Ask the Plant and Pest Professor

## Tomato Plants, Crabgrass, and Kwanzan Cherry Tree

**Question #1:** 

My tomato plants were very healthy this season. I am now noticing some of the leaves turning yellow and then browning. Is this something I should be concerned about? The plants are still producing and I want to make sure I can harvest the rest of the tomatoes.

Answer #1:

The extreme heat and typical tomato diseases, like early blight, challenged tomato growers this season. You are fortunate that your tomato plants were healthy. At this point it doesn't sound like what is happening to your plants is something to be overly concerned about, especially if the rest of the plant looks healthy. Older leaves naturally turn yellow as they age. As the plant matures, it is even normal for the plant to lose some of its older foliage. This process is called leaf senescence. ## **Question #2:**

A Kwanzan cherry tree in my front yard has a large web in it that encases two of the branches. Inside the net are hundreds of caterpillars. What should I do? This is one of my favorite trees in the spring because it blooms so beautifully and I do not want it to be harmed.

## Answer #2:

Your description describes fall webworm Hyphantria cunea activity. You are noticing the second generation of the insect; the first is usually seen in May. This is a native caterpillar that has a large host range including fruit trees. The caterpillars produce a web of fine silk over terminal branches. They only feed inside the web, which they enlarge as they grow. Their presence is not aesthetically pleasing but rarely do they do enough damage to seriously hurt trees. You can choose to do nothing about it, as eventually after the caterpillar activity subsides the web will disintegrate on its own, although that can take some time. If you can reach it, prune the webbing out or use a rake handle to remove the nest. Place a black plastic bag or a bucket of soapy water nearby to dump the

webbing into. Alternatively, B.t. (Bacillus thuringiensis, var. Kurstaki), horticultural oil, or insecticidal soap can be used to control young larvae in large infestations. Break open the webbing and spray the caterpillars and the surrounding branch-

#### **Question #3:**

My lawn is full of crabgrass this summer. Why is it so bad? I know I need to do some overseeding soon. Do I need to kill the crabgrass now? What can I do to prevent this from happening again?

#### Answer 3:

Crabgrass is a very common lawn weed in Maryland. It begins to germinate in the spring and pretty much continues to germinate throughout the hottest part of the summer. It is a summer annual meaning after we have a frost it will die but it will come back next year because of all the seeds that have dropped into the soil. Cultural practices such as thickening up the lawn and proper mower height (3 inches for tall fescue) help to reduce it in lawns. It will also be necessary for you to apply a crab grass preemergent early next spring. Depending on the product two applications about 6 weeks apart are necessary, so read the product label. Herbicides are not very effective on crabgrass this time of year. Begin your lawn renovation project by mowing your lawn at the lowest setting, bag the clippings to capture any seeds, then use a core aerator or slit seeder to distribute the grass seed. ## 100 Years of Accelerating Tomorrow

U.S. Defense Information Systems Agency (DISA) selected Lockheed Martin [NYSE: LMT] for a role on its Test and Evaluation Mission Support Services (TEMSS) program. Six other companies were also selected to compete for future TEMSS tasks, with a seventh supporting other program elements.

Shrewsbury, vice president of technical services within Lockheed Martin's Global Training and Logistics business. "Our experts in information technologies will build on our record of delivering secure systems that DISA can use with confidence."

Lockheed Martin has proven expertise in Command, Control, Communications, Computers and Intelligence (C4I); information assurance; information technology and automated information systems for individual customers and joint entities. The young boy "ParaNorman" suffers from what you might call "Sixth Sense" syndrome, which is the ability to see and communicate with dead people. There are plenty of dead people for him to encounter, too: he lives in New England (that place is crawling with ghosts), and his quaint hometown, Blithe Hollow, has a Salem-like history of executing witches and such. In fact, the 300th anniversary of the town's most famous witch-related incident is fast approaching. Some say the occasion will be marked by the fulfillment of a horrible

Ah, but do not be alarmed! 'Tis all in the spirit of fun that "ParaNorman" tells Halloween-ish tale. Produced by Laika Entertainment (which made "Coraline") using stopmotion animation and marvelously handcrafted models and sets, this slyly macabre zombies-and-ghouls story is meant for kids – kids like 11year-old Norman, actually, who stays up late to watch old horror movies on TV and has gotten used to communing with the dead. Sometimes his late grandmother (voiced by Elaine Stritch) watches with him.

With a small, weak body and hair that stands on end as if he's constantly in a state of fright, Norman (Kodi Smit-McPhee) looks the part of a haunted lad. But his only real source of unhappiness is the way he's

Norman's insane Uncle Prenderghast (John Goodman), who looks like a homeless Fidel Castro, believes him, though that is not much comfort. It's Prenderghast who relates an old legend to Norman, informing him that he may be able to prevent a cemetery full of zombies from wreaking havoc on Blithe Hollow.

The ensuing adventures are great juvenile fun, with Norman, Alvin, Courtney, Norman's fat friend Neil (Tucker Albrizzi), and Neil's dumb-jock brother (Casey Affleck) racing around town in various combinations, trying to ward off an apocalypse. Rest assured, though, it's a family-friendly sort of apocalypse, with the kind of undead stooges one finds in Disney's Haunted Mansion. I can't imagine any kid who enjoys Halloween (I

mean the holiday, not the movie) not being delighted by "ParaNorman."

It's from an original screenplay by Chris Butler, an animator who's also making his debut as co-director (with Sam Fell, who helmed "Flushed Away" and "The Tale of Despereaux"). The story runs out of steam before it's over, and seems to be spinning its wheels for a while. (The story is steam-powered, yet it also has wheels, I guess.) But you could spend all day being caught up in the dazzling and inventive visuals on display, admiring the craftsmanship and artistry required to produce such a colorfully twisted end-of-summer confection.



## Australian Government Will Issue Overdue Apology to 1968 Olympic Hero Peter Norman

In an act as appropriate as it is overdue, the Australian House of Parliament is issuing an official state apology Monday to the country's late, great sprinter Peter Norman. Norman won the 200-meter silver medal at the 1968 Olympics, but that's not why he's either remembered or owed apologies. After the race, gold and bronze medalists Tommie Smith and John Carlos bowed their heads and raised their fists on the medal stand and started an international firestorm. Many see the iconic image and assume Norman was just a bystander to history, or as he would joke, "the white guy." But he was standing in full solidarity with Smith and Carlos, wearing a patch on his chest that reads, "Olympic Project for Human Rights." As Norman recalled to sports writer Mike Wise, when he heard what Carlos and Smith were going to do he had to show his support. "I couldn't see why a black man wasn't allowed to drink out of the same water fountain or sit in the same bus or go to the same schools as a white guy. That was just social injustice that I couldn't do anything about from where I was, but I certainly abhorred it." On that day, Norman earned the undying respect of Smith, Carlos and countless others. But that didn't help him upon returning home.

Credit Australia for telling the truth, that Norman was denied a place on the 1972 team for his political beliefs. Credit Australia to making the apology. But true reconciliation for a man like Peter Norman could never come from a parliamentary apology for a past wrong. It would come from a national commitment to an anti-racist future

Silver medal or not, Peter Norman was now a pariah in Australia, a country that at the time held racial exclusion laws that rivaled apartheid South Africa. He was banned from running. He was denied a spot on their 1972 team after qualifying. He and his family were harassed, refused work, and made to suffer. "Peter always had it harder than Tommie and me," remembers John Carlos. "They took turns kicking our butts. Peter had to face an entire country and suffer alone."

For decades, Peter Norman was invited to condemn Smith and Carlos as well as his own actions. If he had, he would have been re-embraced by the establishment, found steady work through the Australian Olympic Committee, and been part of the pageantry when the Olympics came to Sydney in 2000. But he never wavered and he remained a proud outcast until a fatal heart attack in 2006 struck him down at the all-too-young age of 63. The lead pallbearers at his funeral were John Carlos and Tommie Smith. Now, six years after his death and in the aftermath of what was arguably the poorest Australian Olympic performance in decades, Australia wants to reclaim him as their own. Here is the text of the resolution that will be offered into parliament by MPs Rob Oakeshott and Andrew Leigh:

"That this House; Recognises the extraordinary athletic achievements of the late Peter Norman, who won the silver medal in the 200 metres sprint running at the 1968 Mexico City Olympics, in a time of 20.06 seconds, which still stands as the Australian record;

Acknowledges the bravery of Peter Norman in donning an Olympic Project for Human Rights badge on the podium, in solidarity with African-American athletes Tommie Smith and John Carlos, who gave the black power salute;

Apologises to Peter Norman for the wrong done by Australia in failing to send him to the 1972 Munich Olympics, despite repeatedly qualifying; and Belatedly recognises the powerful role that Peter Norman played in furthering racial equality."

Norman's old comrades are moved by the gesture. I spoke with John Carlos who said to me, "There is no one in the nation of a Australia that should be honored, recognized and appreciated more than Peter Norman. He should be recognized for his humanitarian concerns, his character, his strength and his willingness to be a sacrificial lamb for justice."

Carlos is right and Norman should be recognized. I understand fully why there is joy among Peter Norman's family and friends, and yet I can't help wonder. If Peter Norman were still alive, it is very possible that this stubborn, principled man, would tell the Australian Government to take their apology and stick it down under. I wonder if he'd point out that Australian Olympic boxer Damien Hooper was almost sent home last month for wearing an Aboriginal flag on a T-shirt and the Australian Olympic Committee gave him no support, condemning him for his actions. I wonder if he'd also point out that Aboriginal Australians comprise 2.5 percent of the nation but make up about 26 percent of the prison population. I wonder if he'd rail against the staggering rise in arrests of minorities and Australia's own version of what in the United States has become known as the "New Jim Crow." I wonder if he would take inspiration from the late South African freedom fighter and athletic organizer Dennis Brutus. When Brutus was offered a spot in the South African sports hall of fame, he rejected it saying, among other things, "It is incompatible to have those who championed racist sport alongside its genuine victims. It's time-indeed long past time-for sports truth, apologies and reconciliation."

## EARTH TALK ... The Domestic Fuels Protection Act of 2012

Dear EarthTalk:

What is the Domestic Fuels Protection Act of 2012 and why are environmental groups opposing it?

Domestic Fuels Protection Act of 2012 (H.R. 4345) is a bill that was introduced in the House of Representatives in April 2012 by a bi-partisan group of Congress members to protect domestic producers of ethanol, biodiesel and other greenfriendly fuels from liability to end-users who put the wrong kind of fuel or fuel mix into their tanks and damage their engines and/or emit exaggerated amounts of pollution accordingly. The idea behind the bill is to ensure that domestic "green" fuel and related equipment producers aren't forced into dire financial straits or put out of business due to crippling liability claims.

But some feel that the fuel industry, whether its products are environmentally friendly or not, should be held accountable for damage its products may cause. Most recently, E15, a fuel blend containing 85 percent gasoline and 15 percent ethanol (a renewable cropbased fuel) came under fire for causing engine damage in some older cars and trucks. The EPA approved the use of E15 in 2010 after lobbying from the ethanol industry, which seeks to

up the ethanol content of gasoline from what had been the standard of 10 percent, which is much easier for gasoline engines to tolerate.

The Auto Alliance, an indus-

try group, recently released a study claiming that upwards of five million cars on U.S. roads today could be damaged if owners pump in E15 instead of straight gasoline or even the milder E10 (10 percent ethanol, 90 percent gasoline). "Problems included damaged valves and valve seats, which can lead to loss of compression and power, diminished vehicle performance, misfires, engine damage, as well as poor fuel economy and increased emissions," reports the group, adding that the potential costs to consumers are significant. "The most likely repair would be cylinder head replacement, which costs from \$2,000-4,000 for single cylinder head engines and twice as much for V-type engines."

Environmental and consumer advocates say that H.R. 4345 is a bad deal for consumers who will be left footing the bill for these repairs. The non-profit Environmental Working Group (EWG) bemoans the bill because it would exempt hugely profitable and already "favored interests" including fuel producers, engine makers and retailers of fuels and fuel additives from liability for damage caused by their products.

H.R. 4345 is currently under committee review in the House, but analysts doubt it will ever

make it to a floor vote given the contentious debate surrounding the fact that it puts the burden of repair costs on end consumers. Users on the govtrack.us website (which provides free and comprehensive legislative tracking for everyday citizens) give H.R. 4345 only a three percent chance of passing. Meanwhile, the Senate is considering a companion bill, the so-called Domestic Fuels Act (S. 2264). But unless the House passes its version first, the Senate bill is unlikely to gain much traction.

## **Nuclear Energy Proponent Criticizes** Natural Gas, Upsets Some Delegates

TAMPA. Fla. - A nuclear energy expert from Maryland found himself under fire from some members of the state's Republican delegation during his Monday breakfast speech after criticizing natural gas fracking and its viability as a primary energy source.

Donald R. Hoffman, president and chief executive officer of Excel Services Corporation in Rockville, criticized the lack of research done in local areas before fracking, an unconventional method of gas extraction that involves drilling horizontally into a shale layer and injecting a pressurized mixture of water, sand and chemicals to crack open the rock, releasing trapped gas.

Hoffman contrasted that with the extensive planning done before nuclear plants are

He also characterized the fracking process as under-regulated and unsafe to the surrounding area, and said it doesn't create enough jobs when compared with nuclear plants, which drew criticism from some members of the Maryland delegation.

"There's a huge amount of natural gas in this country and with fracking, we know how to get it out of the ground," former Talbot County Republican Party Chairman Kate Boland said. "It creates jobs. North Dakota and Pennsylvania have low unemployment rates because of energy production. I'm not against nuclear energy at all, but it's not helpful to talk down natural gas." Alternate delegate Jamie

Falcon agreed with Boland's analysis.

"It seemed like his talk should have been more comprehensive. You should be promoting your energy source, not knocking the other ones," Falcon said.



Tampa, Florida, Skyline

Hoffman clarified his comments after hearing from Boland and delegate Greg Fox, who both disagreed with his stance. He said while natural gas is flush in areas like Pennsylvania, and he's supportive of other forms of energy, nuclear energy permits a larger and faster output than natural gas or other alternatives.

Hoffman said two approved nuclear power plants, one in Georgia and one in South Carolina, will create at least 42,000 new jobs, and up to 160,000.

Hoffman said those two plants are the only approved plants in the United States over the next decade, and a fraction of the 30 China plans to build over that same period. Hoffman said three factors have caused a reluctance to approve and use nuclear power, despite the energy source accounting for 20 percent of U.S. energy output.

"There's a severe cost to build the facility before it starts to make money," he said. "Almost \$5 (billion) or \$6 billion must be invested before the plant is operational. Past incidents also contribute to it. Even after studies showed an incident like the one in Japan wouldn't happen here, the public is uneasy about them.

"Lobbyists are also campaigning telling people that solar power and wind power are the answer," Hoffman said. "Sure, they're environmentally great, but it's just not possible for them to be a primary source of energy."

Allegany, Garrett and Washington counties in western Maryland are part of the Marcellus Shale Formation, which is estimated to have the largest onshore reserve of shale natural gas in the coun-

In June, Maryland Gov. Martin O'Malley signed an executive order to examine the environmental impacts of drilling and extracting the natural gas. It is expected to be completed by 2014.

Maryland has just one nuclear power plant -- the Calvert Cliffs plant on the Chesapeake Bay's western shore, but at-large delegate and Maryland House of Delegates member Kelly Schulz, R-Frederick, called nuclear power "something we have to take a look at."

"I'm on the energy committee, and we're focused on finding effective, efficient alternative energy sources, and nuclear power is just that," she said. "We have to take a good, qualified look at it."

Hoffman's speech to the Maryland delegation isn't his only planned address this week. He will speak to the Alaska and Virginia delegates, and possibly several others about nuclear energy.

the state and the Washington Metro area to detect and deter speeding in school zones and work zones and on certain area roads, red-light running, and illegally blowing past railroad crossing signals.

"There are no ifs, ands, and buts about it. Drivers put children at risk and break the law when they overtake a stopped school bus displaying a stop signal-arm and flashing red lights, and they fail to come to a complete stop until all the children have reached a place of safety," said John B. Townsend II, AAA Mid-Atlantic's Manager of Public and Government Affairs. "Yet it happens thousands of times a day across Maryland. The stop-arm cameras will dissuade this reckless behavior."

Last spring, the Montgomery County Council gave the green light to legislation empowering the Montgomery County Police to install stop-arm cameras on yellow school buses. The county became the third jurisdiction in the state to approve the use of the technology for its school bus fleet. When its 2012-2013 school-year commences next Monday, the Frederick County Public Schools will roll out 40 of its 433 school buses fully equipped with the stop-arm cameras.

Most school transportationrelated accidents occur while children are getting on or off a school bus, according to the Mid-Atlantic Foundation for Safety and Education and AAA Mid-Atlantic. It is imperative for parents, school bus drivers, school bus stop monitors, and school children themselves to become aware of the "danger zone" around the school bus. It is the place where most school children face their greatest risk of getting hit by either a passing vehicle or by the school bus itself.

In fact, the area to the left of a school bus is always considered the most dangerous because of passing vehicles. The school bus "danger zone" extends as much as 30 feet from the front bumper, 10 feet from the left and right sides of the bus and 10 feet behind the rear bumper of the school bus. "The stop-arm cameras will save the lives and the limbs of our most precious cargo," added Townsend. "Their presence will give peace of mind to parents, school bus drivers, and students who are unnerved by speedy motorists who refuse to treat the extended stop sign on a school bus like a regular stop sign."

The law in Maryland lays it down. A police officer who witnesses the crime in Maryland can slap motorists with a ticket that carries a stiff fine of up to \$1,000, plus three points on the driver's license. Vehicles are required to stop for school buses loading and unloading children. Under state law the only exception to the rule is if the school bus is across a divided highway with a median. Sadly, many drivers don't know, follow, or obey the Maryland School Bus Stopping Law. If in doubt, stop!

- \* Two-Lane Roadway: When the school bus stops for passengers, all traffic from both directions must stop! You must stop at least ten (10) feet away from the school bus
- \* Two-Lane Roadway With A Center Turning Lane: When a school bus stops for passengers, all traffic from both directions must stop!
- \* Four-Lane Roadway Without A Median Separation: When the school bus stops for passengers all traffic from both directions must stop!
- \* Divided Highway Of Four Lanes Or More With A Median Separation: When a school bus stops only traffic following the bus must stop!
- As it stands, Montgomery County Police only issue around 500 tickets per year to drivers who are caught red-

Motorists approaching from either direction must wait until the red lights stop flashing before proceeding.
